

# E-Z Pass Lawsuit Filed – Please Register!

On October 7, 2021, Sauder Schelkopf filed a class action lawsuit (https://www.sauderschelkopf.com/wp-content/uploads/2021/12/E-Z-Pass-Complaint-as-filed.pdf) on behalf of E-ZPass customers with motorcycle E-ZPass transponders. It has been alleged that individuals with motorcycle transponders have reported being incorrectly classified as other vehicle types, including as cars and trucks, which has led to the collection of excessive fees.

### A New Law to End Drunk Driving - Will it work?

In the United States, there are roughly 28 people who die in drunk-driving crashes each day — that's one person every 52 minutes... that is roughly 10,000 deaths per year. President Biden's \$1 trillion infrastructure bill contains a provision to require automakers to find a way to use technology to significantly reduce this scourge.

Starting in 2026, automakers will have to install technology that detects and prevents drunk drivers from operating their vehicles.

Under the new law, the car must "passively monitor the performance of a driver of a motor vehicle to accurately identify whether that driver may be impaired." Over the next few years, the Transportation Department will assess and choose the technological solution(s).



That technology could be in-car, infrared cameras that monitor driver behaviour and attentiveness. If the system detected impairment, it would issue a warning and, if the behaviour persists, pull the car over to the side of the road and self-disable.

Alternatively, it could be built-in sensors that measure alcohol levels such as an "interlock" device. Under current New York law, anyone convicted of driving while intoxicated must install such an "interlock" device for, at least, 6 months. This device is a breathalyser that works in sync with your ignition. Blow too much and the car will not start or continue to operate. The breathalyser option arguably fails to comport with the law's requirement of a "passive" system and any option could face privacy challenges in the courts.

With that said, the new law a courageous and impressive attack on a long-standing problem in this county. "We applaud the long overdue effort. It's monumental," said Alex Otte, national president of Mothers Against Drunk Driving (MADD). Otte described the new law as the "single most important legislation" in MADDs's history that marks "the beginning of the end of drunk driving."
