Take the NE Extension of the PA tumpike to exit #32 (Quakertown).

Travel North/East on 663/313 to 212 East through Quakertown,

Richlandtown, Pleasant Valley and Springfield. Just after Springfield

Elementary school (on right) turn right onto Township Road. Travel approx. 1.5 miles to Burnsonville Road and turn right. Travel approx. 3/4 of a mile to Winding Road and turn right. Travel approx. 1/2 mile, farm entrance is on left. Total time from tumpike is approx. 25 minutes.

From NYC and points North.....

Take Interstate 78 West thru NJ to Eastern Pennsylvania. Take Hellertown exit #21 (approx. 9.3 miles from Delaware River Toll bridge) onto PA Route 412 South. Continue South on Rt. 412 10 miles thru the towns of Hellertown and Springfield to Burnsonville Road. Turn right onto Burnsonville Rd and continue 1.3 miles until Winding Road.
