I. CALL TO ORDER: The meeting was called to order at 1:05 P.M. by President Jose Reyes in the Windsor Room, Vernon Quality Inn and Conference Center, Vernon Connecticut.

IIA. IV. APPROVAL OF MINUTES: The minutes of the 99th meeting were accepted as mailed (Motion to accept by Long Island Spuds, seconded by Iron Guard).

V. OFFICER REPORTS:

A. Treasurer: Account balance is \$507.06, patch balance is 147.

B. Secretary: Correspondence was read from SNC London, Pittsburgh MC and Vikings MC.

C. Vice-President: Presented calendar of events and deferred the balance of his report to New Business.

D. President: The chair proposed a committee to explore new ideas and ways to strengthen A.M.C.C.. Committee members are:

The chair also requested that the **Shipmates Club**, **Griffin MC** and **C.O.M.M.A.N.D. MC** combine to hold a function that evening.
- B. Ed Glaser read a letter he had received from the **Long Island Spuds** requesting that he advise A.M.C.C. and it's members that the **Long Island Spuds** had disbanded. **Pennsmen** offered best wishes to the membership of the **Long Island Spuds**.
- C. **Shipmates Club** proposed **C.O.M.M.A.N.D. MC** for membership into A.M.C.C.. **Empire City MC** seconded the proposed membership. The Chair read a letter from the **Hartford Colts MC** in support of the proposed membership.
- D. **Hartford Colts** (Joe Y.) proposed establishing an AMCC PC Network. He proposed that the network be based in Hartford with a central database. **Highwaymen TNT** raised a question regarding security of the network. **Wheels MC** moved to table discussion to the 101st meeting and the motion was seconded by **Iron Guard**. The motion to table passed. The Chair appointed the Secretary to further research this idea and to report on it at the 101st meeting.

C. **Vikings MC** announced a bar night at the Bike Stop in Philadelphia on July 27 from 8 to 10 PM.

D. **Hartford Colts** presented the meeting attendees with key chains commemorating the 100th meeting and also presented a cake to the Chair.

E. **Thunderbolts MC** announced a bar night on September 14 at the Bike Stop in Philadelphia.

F. **Philadelphians MC** will be presenting a "Bootblack" Social at the Bike Stop on September 15 from 4 to 8 PM.

A. Don Lehrman of the **Long Island Spuds** thanked the members of the Council for their support and brotherhood over the last 17 years.

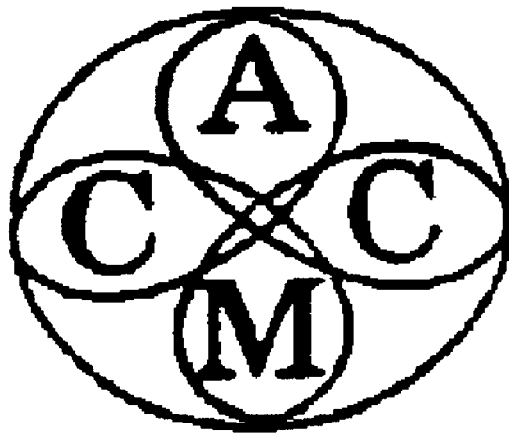
B. **Spartan MC** proposed two resolutions:
