

I. The 105th meeting of the Atlantic Motorcycle Coordinating Council was called to order at 1:38 P.M. by President Jose Reyes at the Dugout, 185 Christopher Street, New York.

IIA. PRSENT: Bucks MC, Centaur MC, C.O.M.M.A.N.D. MC, Cycle MC, Empire City MC, Entre Nous, Excelsior MC, MC Faucon, Griffins MC, Highwaymen TNT, Iron Guard BC, Lost Angels, Pennsmen Inc, Philadelphians MC, Shipmates Club, Spartan MC, Vanguard MC, Vikings MC and Wheels MC.

IIB. PROXY: Crucible MC, Hartford Colts MC, Pittsburgh MC, SNC London and Thunderbolts MC.

IIC. ABSENT: Pocono Warriors, Reading Railmen and Scorpions MC.

III. GUESTS: Long Island Ravens, Satyrmn, Howard G. (Asst Manager, Bike Stop) and Pat P. (GDI).

IV. On a motion by the Centaur MC, seconded by Spartan MC, the minutes of the 104th meeting were accepted as mailed.

V. OFFICER REPORTS:

A. PRESIDENT: Remarks deferred to appropriate portions of the meeting.

B. VICE-PRESIDENT: Provided calendar of events. Requested that all items for inclusion in the calendar of events be provided to him at least 15 days prior to the meeting. Remainder of remarks deferred to New Business.

C. SECRETARY: Reviewed mail from MC Faucon, Philadelphians MC, MS Panther KOLN, Iron Guard BC, National SM/Leather/Fetish Contingent, European Conference of Motorcycle Clubs, LMC Vienna, MSC Finland, Loge 70 Suisse, NLA Houston, Moor Cocks and Long Island Ravens. Requested all roster changes be submitted as soon as possible.

D. TREASURER: On a motion by Pennsmen, seconded by Iron Guard, the Treasurer's report was accepted as presented (copy attached). Reviewed prices regarding new AMCC patches and deferred discussion on the issue to New Business.

VI. COMMITTEE REPORTS:

A. The March on Washington committee reported that housing reservations are rapidly becoming scarce and recommended that reservations be made ASAP. Limited private housing will be available to PWA's.

Also discussed were arrangements concerning an AMCC reception during the weekend of the March. Further discussion was deferred to New Business.

VII. OLD BUSINESS:

A. Sanctioned Calendar for 1993:

1. Changes: Pennsmen Inc to February 19-20-21, C.O.M.M.A.N.D. MC to November 5-6-7 and Highwaymen TNT to May 7-8-9.

2. On a motion by Philadelphians MC, seconded by Griffins MC, the Sanctioned Calendar for 1993 was accepted as amended (copy attached).

B. Nominations and vote on the Torrid Tuber:

1. Shipmates Club nominated Centaur MC for (1) "losing the hula dancer" and (2) "mounting it with a light that was not grounded and nearly electrocuting several Shipmates".

2. Centaur MC nominated:

a. Griffins MC for "inferior entertainment at dinner at Griffin Flight".

b. Entre Nous for "late dinner in Orlando due to elevator trouble".

c. Vikings MC for "non-brunch brunch at BO2".

3. C.O.M.M.A.N.D. MC nominated Griffins MC for "the cruel and inhumane use of live goldfish in their dinner floral arrangements".

4. Empire City MC nominated Excelsior MC for "while fully believing in biodegradability in everything you use, when you have cups that biodegrade when you put beer in them, it's too much".

5. Griffins MC nominated:

a. C.O.M.M.A.N.D. MC for (1) "the way they verified all registrations on the weekend so that we all knew to go to the Eagle to sign up" and "for their dinner, for the meals for eighty, seating for twenty, fifteen of which were C.O.M.M.A.N.D. members".

b. Excelsior MC for "having strictly Pepsi products. We prefer coke because real men like the real thing".

c. Wheels MC for "chicken cordon bleaucicles without having the popsicle sticks in them to help eat them".

d. AMCC Officers for "scheduling a meeting in the middle of December during a blizzard".

6. On a motion by Spartan MC, seconded by Pennsmen, further nominations were closed. The Chair requested that our guests from LI Ravens be the vote counters. After a brief pause, the Chair announced that the recipient of the Torrid Tuber was C.O.M.M.A.N.D. MC..

VIII. NEW BUSINESS:

A. Nominations for 1993 - 1995 Officers:

1. Iron Guard BC and MC Faucon nominated C. B. Miller for President. Entre Nous nominated Joe Laing for President. On a motion by Iron Guard, seconded by Spartans, further nominations were closed.

2. C.O.M.M.A.N.D. MC nominated Dan Dutcher for Vice-President. Entre Nous nominated Marshall Kyle for Vice-President. MC Faucon nominated Joe Sullivan for Vice-President. Philadelphians MC nominated Rodney Knowles for Vice-President, but Rodney graciously declined the nomination. On a motion by Shipmates Club, seconded by Entre Nous, further nominations were closed.

3. Wheels MC nominated Rodney Knowles for Treasurer. C.O.M.M.A.N.D. MC nominated Eric Whitmer for Treasurer. Excelsior MC nominated G. E. Mayo for Treasurer. On a motion by Iron Guard BC, seconded by Entre Nous, further nominations were closed.

4. Shipmates Club nominated Rodney Knowles for Secretary. Vikings MC nominated Bob Kavlin for Secretary. On a motion by Entre Nous, seconded by Pennsmen, further nominations were closed.

5. The Chair advised that ballots will be mailed with a stamped, self-addressed envelope for return to him. At the 106th meeting, the ballots will be opened, counted and the results will be made known to the Council.

B. Location of the 107th meeting: The Vice-President indicated that requests for the meeting had been received from Shipmates Club and Highwaymen TNT. Based upon his calculations, the 107th meeting will be hosted by Highwaymen TNT. The Vice-President reminded all that requests for meetings must be received by the VICE-PRESIDENT thirty (30) days prior to the meeting at which the selection will be made (requests for the 108th meeting must be received by ED GLASER no later than January 20, 1993).

C. Other New Business:

1. Purchase of new AMCC patches. The Treasurer again reviewed estimates received regarding new AMCC patches. Lanoueye had the lowest price. Griffins MC, seconded by Pennsmen, moved that the Council purchase 200 patches from Lanoueye for a cost of \$310.00 plus shipping and handling. The motion passed. (A copy of the quotes are attached.)

2. Lost Angels, seconded by Entre Nous, moved that the MOW committee be authorized to plan a reception on behalf of AMCC during the MOW for invited guests. Many points of view were expressed during the ensuing discussion, including AMCC's mandate by the Articles, the Council being labeled by it's participation with certain groups, the cost of such a function, the substance of the function and housing during the weekend. The Philadelphians MC called the vote and the motion was defeated.

A Committe motion was then placed on the floor as follows: AMCC will march as a unit within the Leather Contingent, carrying the AMCC banner. The motion was amended by Griffins MC, seconded by Centaur MC, to remove the Leather Contingent. Again, several points were discussed including the reasons for marching, the non-political stance regarding the platform and that the committe should facilitate amoungst the member clubs to coordinate participation all weekend. Griffins MC called the vote and the motion passed.

3. Griffins MC, seconded by Centaurs, moved that since there are other pride parades than New York, AMCC support rotating participation in pride parades, determining location by lot or ballot or other means so long as a different location is supported each year. On a motion by Spartans MC, seconded by Entre Nous and Shipmates, further discussion was tabled.

IX. CLUB ANNOUNCEMENTS:

A. Centaur MC - Leather Weekend brochures are late but coming.

B. Spartan MC - Flyers are available for Marathon '93. Please remember that marathon is open to all participants, no just bikers.

C. MC Faucon - Club nites at the Black Eagle are not happening. Migration will occur. All are invited to "Kings Dinner" on February 6, 1993.

D. Pennsmen Inc - Phil Simone is the new President of the club. If you are doing a cocktail party in a public space during their run, you may not bring your own booze.

E. Vanguard MC - Come greet the new officers at the Handshake Affair on February 6, 1993.

F. Philadelphians MC - There is still some room on TRI-CEN IX, so get your applications in.

G. Shipmates Club - 19th Anniversary will be held April 2-3-4 and Keelhaul (with ADULT meals) will be held May 28-29-30-31.

H. Entre Nous - Friends and Lovers run will be the 12-13-14th of February in Provincetown and Equinox will be in Orlando FL the 17th thru 23rd of March.

I. Excelsior MC - will be hosting a joint bar nite with the Long Island Ravens on January 30 at the Spike.

X. GOOD AND WELFARE OF THE COUNCIL:

A. The Chair thanked Iron Guard BC and Cycle MC for their hosting of the meeting.

F. The Chair thanked all who called or sent cards to Ken, it is appreciated muchly.

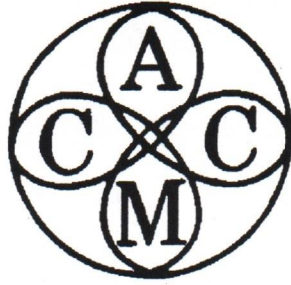
G. Lost Angels suggested that those attending Leather Weekend stay an extra day and enjoy all the inaugural balls (gay and otherwise).
