D. Spartan MC announced that, as of December 10th, Defenders of D.C. were now members of CAB.

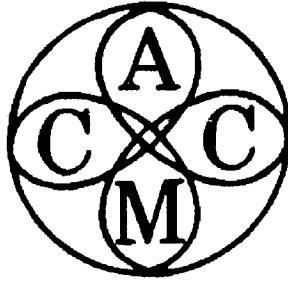

MARCH ON WASHINGTON COMMITTEE
