# Atlantic Motorcycle Coordinating Council

- I. The 107th meeting of the Atlantic Motorcycle Coordinating Council was called to order at 1:05 P.M. by President Joe Laing at the D.C. Eagle, Washington, D.C.

- III. GUESTS: Long Island Ravens.
- IV. On a motion by the Centaur MC (second by Spartan MC) the minutes of the 106th meeting were accepted as mailed.
- V. OFFICER REPORTS:
  - A. PRESIDENT: The president read a letter from Lee Humphrey announcing the dissolution of the Thunderbolts after 23 years existence.
  - B. VICE PRESIDENT: Marshall reported on the March on Washington. There was a good turnout from the Leather community.
  - C. TREASURER: The treasurer report was presented verbally. The current balance is \$273.42 with \$10.50 due. AMCC patches are available.
