- I. The 108th meeting of the Atlantic Motorcycle Coordinating Council was called to order at 2:12 P.M. by President Joe Laing at the Central Station, Baltimore, MD.
- IIA. PRESENT: Bucks MC, Centaur MC, C.O.M.M.A.N.D. MC, Crucible MC, Cycle/Wheels MC, Empire City MC, Entre Nous, Excelsior MC, MC Faucon, Griffins MC, Highwaymen TNT, Long Island Raven, Lost Angels, Pennsmen, Philadelphians MC, Pittsburgh MC, Pocono Warriors, Reading Railmen, Scorpions MC, ShipMates Club, Spartan MC, Vanguard MC, and Vikings MC.

- III. GUESTS: None.
- IV. The minutes were corrected to show MC Faucon present. On a motion by the Centaur MC (second by Spartan MC) the minutes of the 107th meeting were accepted as corrected.

X. GOOD AND WELFARE:

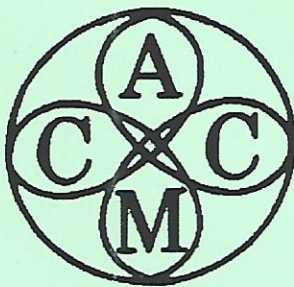
A. The Chair thanked C.O.M.M.A.N.D. for hosting the meeting.


