These are the Minutes of the 185th AMCC meeting held at the Clarion Hotel in Portland, ME, on Saturday, November 11, 2017.

CALL TO ORDER

President (Ed Caraballo) called the meeting to order at 1:03 p.m.

<u>MINUTES</u>: The following changes are being made to the 184th meeting minutes.

Under the heading MINUTES, it was indicated that amendments were made to the 183rd meeting minutes. There were no amendments. The minutes were approved as presented. Here the actual amendments to the 184th Meeting Minutes:
