2. Clarification requested by Sam J., Vikings MC

A one day event refers to a calendar day, ie, July 4, not a 24 hour period ie. 12 noon July 4 to 12 noon July 5.

3. Clarification requested by Joe K., Entre Nous

Clubs already in planning for a second run within the current calendar (1974) may proceed with the run.
