

The 32nd meeting of the AMCC, hosted by Entre Nous, at Boston, March 22, 1975

The president called the meeting to order at 3:20.

The secretary called the roll, all clubs present or present by proxy.

The secretaries report was accepted as read.

The treasurer reported an expenditure of \$33.90 to Trophy World, for updating the AMCC Membership Plaque; the current balance is \$293.83. His report was acknowledged as received.

OLD BUSINESS

The AMCC '76 Run Committee report was waived; all members of the council had attended the meeting. The Council voted to accept the actions of the run committee.

NEW BUSINESS

The N.Y. Levi Guys nominated the Praetorians for membership into the council. Wheels MC seconded. Norman O., Wheels MC, spoke for the Praetorians. He stated they had 13 members; were an established club; he noted that their application was a compliment to the council. They were originally opposed to the concept of the AMCC, but now realize the viability of the AMCC. Bob M. N.Y. Levi Guys, concurred with Norman, and added that he thought they would be an asset to the Council.

The N.Y. Levi Guys nominated the Philadelphians for membership into the council. Vanguard's MC seconded. John H., Vanguard's, spoke for the Philadelphians. He said he was proud of them, that they were not a split-off from another club. He noted that they were an active, cooperative club. They are a viable club organized for 6 or 7 months with over 20 members. He felt they would be a good addition. In regard to their activity, Tim T. noted that they had 100% attendance at Autumn scrambles. Joe K. noted that 7 members were at Days of Equinox. The Bucks stated they were a freindly club that supported the other Philadelphia clubs and that the Bucks had presented their colors to the Philadelphians.

The vote on the two clubs will be at the next meeting.

Al C. appointed John Hayter and Bill Enwright to the Election Committee and asked them to count the ballots. While the ballots were being counted Al asked for a date for the next meeting. The Vikings MC moved that the next meeting be held at the Centaur Run, Olympia IV, May 17, 1975. The LI Spuds seconded. The motion carried. The SMC Lost Angels moved that the minutes or a summary of the minutes of AMCC Meetings be sent to all Club Publications for accurate information of Council Activities. The Levi Guys seconded. The motion carried. Al then asked for the election results. The committee announced the following were elected: President--Tim Tully, Vice-President--Sam Johnson, Secretary--Ed Nesbit, Treasurer--Jim Gress.

The NY Levi Guys moved that the secretary send a letter to the outgoing officers expressing the appreciation and gratitude of the council for their services. The Vanguard's seconded. Al stated he would not like to preside on the question since he was leaving office. He tabled the motion till the new officers took office.
