

ATLANTIC MOTORCYCLE COORDINATING COUNCIL

Minutes of the 9/16/78 meeting.

The 52nd meeting of the AMCC convened at 12:35 on Saturday, September 16, 1978, at the Howard Johnson Motor Lodge, held in conjunction with the Vanguard's/Empire City joint "Septemberfest" run. All Council members with the exception of the Scorpions were represented. Among numerous guests were Duke Camerer of Blue Max C.C. (St. Louis), Jerry Johnson (Druids), Pierre of M.C. Faucon (Montréal), Arvid Duerr of the Constantines (San Francisco), Dick Hoague of the Celts (Mobile), and Dick Barili of the Avengers East (Northern New Jersey). Apologies for any inadvertent omissions. President Don Craver presided.

The Secretary read the minutes of the previous meeting (at Spartans' "Marathon"), and noted two minor corrections: the Pennsmen, not the Iron Guard, purchased 25 patches for \$18.75, not \$18.25. The minutes were then approved.

The President announced that AMCC has been kept alive legally by reregistered (in Washington) as "AMCC '76, Inc." To effect the change to AMCC, Inc., a Council action previously approved, will require more time and paperwork. Don is proceeding with this task.

The President again noted the availability of AMCC '76 memorabilia, and business was brisk following adjournment. Proceeds will help defray AMCC expenses incurred by the President (postage, phone, etc.).

Tony Bachrach (Centaur's), chairman of the Point System Committee, discussed further refinements of the proposed system. The draft, as amended and corrected at this meeting, is attached to and is a part of these minutes.

The election, by written ballot, of the Excelsiors M.C. of New York City and the re-admission of the Vikings M.C. of Boston, was overwhelmingly affirmative; no nay votes were cast. Congratulations of the President were extended to the two new members.

It was moved and seconded (NYLevis/Spartans) that clubs propose to their individual memberships that the Council President be invited as the guest of the hosting club(s) at any Council-sanctioned event. Bill Yonke (Bucks) added that clubs might, at their discretion, underwrite the run fee for the Council representative at runs where AMCC meetings are to be held.

It was suggested that any club unable to collect run fees or received rubber checks notify the Secretary, who will disseminate a list of such individuals with, but not a part of, Council minutes, in order to protect other clubs from similar experiences. Affected clubs should photostat bad checks returned to them.

The President asked for preliminary run and event dates, and the following were sanctioned for the 1979 calendar year:


