The 59th meeting of the AMCC convened at 2:45 p.m. on Saturday, May 17, 1980, in conjunction with the 5th anniversary of Excelsior M.C. in New York City. Council President Don Craver (ShipMates) presided, with all AMCC officers present. All Council members were represented in person with the exception of SNC of London and the Scorpions, both represented by proxy. The Druids, candidate for readmission to the Council, ASMC of Boston and the Iron Cross of Montréal were represented as guests of the Council/Excelsior.

OLD BUSINESS:

Secretary Roger Pegram (Vanguards) read the minutes of the last meeting (March 15, 1980, Boston), which stood approved as read with the correction of a couple of dates.

The President delayed the Treasurer's Report until the vote on the Druids took place; the Washington club was unanimously reelected to the Council; membership now stands at 24.

The President also directed that the vote for the \$10 assessment per club for the Council Treasury be taken at this juncture; unanimously passed. (Several clubs had already sent assessments, and two were collected at this meeting.)

Treasurer Paul Rose (Spartan M.C.) gave his report, which showed a balance of \$299.06 as of 5/17/80, and noted that all AMCC monies will henceforth be placed in our savings account, thereby drawing interest on all funds and eliminating service charges. The report is attached to the official copy of these minutes.

President Craver read a letter received from MSC-Berlin thanking the Council for the congratulatory telegram sent (by Craver) to the Berlin club on the occasion of its Easter run.

NEW BUSINESS:

A letter received by several Council members from someone in Massachusetts named Peterson, charged with a hit-and-run accident, requesting aid for the forthcoming trial, was discussed. The President asked Boston clubs for comments; reaction negative, and the Council takes no action.

M.C. Faucon, the Vikings, the Centaurs, and the Prætorians all offered to host the next Council meeting. Vice President Keith Battin (Empire City) motioned that, in view of the Bucks' gracious withdrawal of hosting this or the next meeting, the Council hold its next meeting in Montréal with M.C. Faucon, since the Faucon invitation has been outstanding since the last meeting. Motioned and seconded (Empire City/Spuds), and passed.

Sanctioned dates department: Druids Prexy Bob Morrow indicated that his club's late-October anniversary, normally invitational, will be open this year, and requested sanction for Saturday, October 25. Lost Angels' representative and former Council President Tim Tully questioned two sanctioned events in the same city on consecutive weekends (the LAs hold sanction for Oct. 31-Nov. 1 & 2). The President reiterated Council Articles, which do not prohibit this. Moved (Spuds/Centaurs) and passed to sanction Druid requested date.

Bob Hullen noted that the Praetorians' 10th Anniversary might be moved from Saturday, October 11, to Sunday, October 12. Vanguard's Captain Ed Doyle requested a change in sanctioned dates from September 12-14 to September 19-21, since a site for Septemberfest has been located. Moved (Links/Entre Nous) and passed.

Cal Riley announced that the Spartans' 12th Anniversary (July 11-13) is not limited solely to bikers. Since the run will be taking place at two sites (DC and Altlands Ranch), participants may select either or both parts of the event. The Friday night portion will not be taking place, as previously announced, at the Eagle in Exile; probable site: Mai Ling's "Sojourn" bar in Washington.

Prexy Dean Sandford of Wheels M.C. noted that SNC of London selected run dates in direct conflict with those of Wheels M.C. The President noted that SNC is a Council member, and that it will be assessed \$10. He said that while probably not one participant at either event would ~~the~~ be affected, this did violate the Articles of Agreement. He further asked if a reprimand was recommended. Moved (Wheels M.C./Vikings) and passed so to do.


GOOD & WELFARE:

Don Jedrey (Vikings) noted that the new "Chains of Brotherhood" used the wrong logo depicted for AMCC. President Craver explained that the Council patch does not reproduce well (we have no graphics for it) and that "Chains" used the "AMCC '76" run pin for our symbol. In response to his inquiry, Joe Smith (Vikings rep) was advised that the Treasurer holds Council patches and all orders should be placed with him.

In closing the meeting, the President reminded clubs that they might be thinking about '81 dates to be sanctioned since many sites require long lead times, and that AMCC officer nominations for the forthcoming 2-year term ('81-'83) will be considered at the next two meetings. The Torrid Tuba, now in the custody of the Vice President (since the Council itself is the present recipient), will be awarded at the close of this calendar year, with one vote @club.

The President thanked Excelsior for its gracious hosting. Motion to adjourn (Praetorians/Vikings) at 3:30 p.m.


