

NEXT MEETING
Saturday, April 17, 1982
Druids' Spring Sabbat Run
Washington, DC

The 66th Meeting of the AMCC was called to order by President Keith Battin at 2:30pm on Saturday, December 12, 1981, at the Spike Bar in New York City. This meeting was held in conjunction with Empire City MC's Christmas Party which was to be held later the same day. All AMCC officers were present. The following clubs were present in person: Bucks, Companions, Druids, Empire City, Entre Nous, Excelsior, Faucon, Iron Guard, Lost Angels, Praetorians, Railmen, ShipMates, Spuds, Spartan, Thunderbolts, Vanguards, Vikings, Warriors, Wheels. The following clubs were present by proxy: Centaur, Pennsmen, Scorpions, SNC. The Links were absent. Jim Gress of the New York Levi Club was the only guest present.

The minutes of the 65th Meeting of the AMCC were read and stood approved as submitted. The Treasurer handed out a written report. It showed a cash balance of \$712.96 and an inventory of 129 patches. The official copy of his report is attached to the official copy of these minutes.

The President called on the Secretary to read each section of the proposed Article VII of the Articles of Agreement. Each section was read in turn and the following changes were offered:

Article VII, Section B--

Delete the entire sentence which reads: Sanctioned events may last from one day/night to seven day's duration. So moved by the Druids and seconded by the Vanguards.

PASSED 13-yes 4-no 6-abstain [Simple majority needed to pass a wording change]

Article VII, Section C--

Change the 100 mile radius to a 50 mile radius

So moved by the Druids and seconded by the Praetorians.

PASSED 14-yes 2-no 7-abstain [Simple majority needed to pass a wording change]

At this point the President called for a vote on the entire Article VII which now included the above two changes. [This Article had been previously placed on the floor by action taken at the 65th Meeting]

PASSED without dissent [Had to pass by at least 19 votes; 20 yes votes cast; there were no 'no' votes and 3 abstains]

The President called on the Secretary to read all of the proposed Article VIII of the Articles of Agreement. The following change was offered:

Article VIII, Section C--

Substitute the word 'scheduled' for the word 'official'.

So moved by the Vikings and seconded by the Thunderbolts.

PASSED 16-yes 1-no 6-abstain [Simple majority needed to pass a wording change]

At this point the President called for a vote on the entire Article VIII which now included the above change. [This Article had been previously placed on the floor by action taken at the 65th Meeting]

PASSED without dissent [Had to pass by at least 19 votes; 19 yes votes cast; there were no 'no' votes and 4 abstains]

The Sanction Calendar for 1982 was now taken up. Dates for sanctioned events were requested by the Centaurs, Companions, Iron Guard, Links, and Warriors which had not been noted in the listing from the 65th Meeting. Faucon and the Spartans requested changes in their previously announced dates. The list then read:

The President then called for nominations for the coveted Torrid Tuber. The following clubs were nominated: Bucks "for their magnificent out-presenting presentation at Keelhaul '81";Lost Angels "for cancelling their run";Spuds "for late 1980 run pins"; Vikings "inasmuch as Boston is a very good home for the Torrid Tuber." Ballots vere distributed and the results were: Vikings-7, Bucks-6, LA's-5, Spuds-3. The Vikings puzzled as to how to take back this 'trophy' on the plane. It had been decorated for the occasion by Entre Nous with blinking lights and tinsel.

The Secretary said that the AMCC had to file its 1981 Annual Report with the DC government. The cost would be \$6.00. He also asked whether the Council wished to keep its current corporate name of AMCC '76 or to have the '76 dropped. The Vikings seconded by Wheels moved to pay the \$6.00. This motion passed without dissent. Excelsior moved and was seconded by the Companions to retain the current name of AMCC '76. This motion passed without dissent.

The President asked that the Council decide where the 67th meeting would be held. Entre Nous, the Druids, and the Warriors had all offered to host a meeting. By Council vote, it was decided to hold the 67th Meeting during the Druid Spring Sabbat Run, April 16-18, in Washington, DC.

MC Faucon and the Bucks both made a request to host a Council meeting at their respective runs.
