NEXT MEETING

Saturday, August 28
MC Faucon's "Migration"
St. Alphonse, Québec

The 68th Meeting of the AMCC was called to order by President Keith Battin at 12:10pm on Saturday, July 3, 1982, at Hauska House in Saylorsburg, PA during the Bucks MC run: "PowWow/South of the Border." The Vice-President was absent. The following clubs were present in person: Bucks, Companions, Druids, Empire City, Excelsior, Faucon, Lost Angels, Pennsmen, Railmen, ShipMates, Spartan, Spuds, Thunderbolts, Vanguard's, Warriors, Wheels. The following clubs were present by proxy: Links, Praetorians, SNC. The following clubs were absent: Centaur, Entre Nous, Iron Guard, Scorpions, Vikings. The following guests were introduced: Tom Gallagher, President of the Trenton Bulls; John Rocco, Captain, and Frank Gould, Treasurer of the Philadelphians MC; Jim Gress, GDI.

The minutes of the 67th Meeting were read and stood approved as submitted. The Treasurer handed out a written report showing a cash balance of \$740.67 and an inventory of 47 patches. The official copy of his report is attached to the official copy of these minutes. Jerry Reber had ordered new letterhead at the request of the Secretary. The price he was quoted was \$107.27 for two reams. Upon delivery of the letterhead, the shop pointed out minor flaws and said that they had reordered for us at no additional charge. The AMCC now has four reams of letterhead. Joe pointed out that the patch supply was low. The Secretary read a letter from Lion Brothers of Owings Mills, Md., which is the patch supplier for the AMCC, which said that they had been able to lower their prices.

MOTION (ShipMates/Faucon) To authorize the purchase of new patches.
PASSED without dissent

The President called on Mike Bridger of Faucon, chairman of the committee investigating the feasibility of an AMCC sponsored interclub publication to make a report. Mike referred to his letter to the committee of April 20 which asked whether or not such a publication was even desired and if so, what form should it take. The committee had responded that such a publication was desirable and that it should be in the form of a quarterly addendum to the minutes of the AMCC and should consist of a calendar, club submitted articles, and run flyers at a nominal charge. It was not felt that a publication of the scope of the former Wheels Magazine should be undertaken at this time. At this point, Alan Smith, President of Wheels MC, which publishes Tread Magazine, said that Tread would be willing to publish a calendar, well written and edited club articles, and run flyers at a charge to be determined. It was pointed out that

the actual production costs of a limited edition newsletter and the purchase of a duplicating machine were rather minimal. Wheels MC said that although costs of the actual production were minimal that the time involvement and personnel needed to publish were not and that at some point a regular staff from the AMCC might have to be appointed to aid the staff of Tread.

MOTION (ShipMates/Spartan) To delay for one calendar year further deliberation and consideration of the matter of the AMCC sponsored newsletter/interclub publication in favor of the offer from Wheels MC to undertake the matter in Tread Magazine and to make the Vice-President the liason between the AMCC and Tread.
PASSED without dissent

The President called for a vote on the election to membership in the AMCC of the Philadelphians MC. Ballots were distributed and upon counting them it was determined that the Philadelphians were elected unanimously. They were given a round of applause. The Philadelphians ask for sanction for their run, "Tri-cen" to be held in Philadelphia on December 31, 1982-January 2, 1983. There was no objection and sanction was granted.

The matter of where and when nominations and election of AMCC officers was brought up. The Council is scheduled to meet next at MC Faucon's run, August 28, 1982. The Lost Angels, November 5-7, and the Spuds, December 3-5, and the Philadelphians, December 31-January 2 all offered to host Council Meetings at their runs during those times. MOTION (Thunderbolts/ShipMates) That the member clubs should be prepared to come to the Faucon run with sanction requests for 1983 and nominations for AMCC officers knowing that neither might be necessary at the meeting.

PASSED 15-yes 3-no 1-abstain

MOTION (Excelsior/Lost Angels) To hold one more meeting of the AMCC during 1982 and that its location will be determined at the Council Meeting at the Faucon run.

PASSED 18-yes 1-no

The Warriors announced that Skinny Dip, August 14, would be limited in that each Warrior would get to bring one guest and that the remaining spots not so taken would be on a first apply/first come basis. If you want to go, ask a Warrior. Faucon announced that "Migration" was rapidly filling up and to apply quickly so that you will not be disappointed to find it filled when you wish to attend.

MOTION (Spartan/Excelsior) To adjourn.
The President adjourned the meeting at 1:05pm.
