1. GENERAL AND ADMINISTRATIVE

A. Introduction

The 75th Meeting of the AMCC was called to order by President Paul Rose at 1:20 p.m. on Saturday, April 14, 1984 at The Gallery, Baltimore, MD during the weekend of the Shipmates 10th Anniversary.

B. Roll Call

All clubs were present in person except for the Centaurs and Philadelphians. The usual SNC London proxy applied.

C. <u>Guests</u>

Ralph Lepage of the ASMC Boston and Marvin Deutsch, President of the New York Tridents were welcomed as guests.

D. Minutes of the 74th Meeting

On the motion of Spartans/Entre Nous the Minutes of the 74th Meeting were accepted as read.

E. In Memoriam

A minute's silence was observed in memory of Dan Dailey. Paul Rose noted Dan's role as founder and developer of the club scene, both on the East Coast and in Europe.

F. Officer's Reports

The President confirmed that filing of the necessary corporate certifications had been completed. Written offers to host future meetings had been received from the Bucks and the Pocono Warriors. A jointly signed letter had been received from Empire City and the Praetorians confirming their agreement on joint sanction of their 5-8 October 84 activities.

The Vice-President stated that Tread Magazine would be re-printing former acticles for their 15th Anniversary issue, therefore new submissions were not being immediately printed.

The Secretary stated the need for all member clubs to certify their membership to the Executive as of 1 January 1984 and apologised for not having followed the tradition of his predecessor in issuing pre-printed forms for the purpose. The Secretary promised corrective action.

The Treasurer reported a cash balance of \$742.65 with an inventory of 167 patches on hand. An account receivable of \$45.00 from the Crucible was noted.

2. CORRESPONDENCE

The Cell Block of Philadelphia wrote to the Council offering member clubs facilities for banquets and bar nights. George McGinn was nominated as the Cell Block's point of contact.

3. OLD BUSINESS

A. Ride Rules Committee

Joe Marengo presented the second part of the Committee's recommendations, that dealing with bike events at runs. The major feature stressed in the report was safety. It was noted that non-bike clubs who planned to hold biking events at their runs should pay attention to the suggestions made. Comments are to be forwarded to Joe Marengo. A vote for adoption of the recommendations is scheduled for the next meeting.

B. <u>Tie-Breaking/Ballot Mailing Committee</u>

The Committee recommended that the Articles of Agreement stand as written on the grounds that the current wording reflects the interests of the clubs as a whole rather than the individuals within the club on the issue of ballot mailing. Similarly, in Council Meetings, to give the President a tiebreaking vote would elevate an individual above the level of the clubs. On the motion of Vikings/Spartans the recommendations of the Committee were accepted without dissent.

8. CLOSING REMARKS



ATLANTIC MOTORCYCLE COORDINATING COUNCIL

The Articles of Agreement should remain unchanged in respect to having no provision for breaking a tie and in respect to the mailing of ballots to the clubs. The AMCC is an association of member clubs; it is not a club, it is not an association of individuals. You sit here representing your club, not yourself. The officers of the AMCC, and especially the President, were chosen by our clubs. He is to manage the affairs of the AMCC as we decide, as our clubs decide. In that role, he belongs to all of us as do all the officers.

Since the AMCC is an association of clubs and not individuals, to give the President a vote, even to break a tie, would be to give an individual and not a club, a vote. To do so would be to change the character of the AMCC and the principles it was founded upon and upon which it operates. If the President of the AMCC, at any given meeting, is the representative of his club and casting his club's vote, then he has a vote by virtue of representing his club. If there is a representative from his club at that same meeting, that representative should vote for that club. To give the President a vote in that case, even to break a tie, would be to give the President's club two votes at that particular meeting. The Articles of Agreement clearly state that each club is to have only one vote.

The same general principles hold true when it comes to the mailing of ballots for the election of AMCC officers. The AMCC is an association of clubs, not an association of individuals, not an association of individuals who represent their clubs. On that operating principle, is is proper to mail the ballot to the club and not to an individual in the club. It is the club which casts a vote; no individual in the club casts the vote. The club should within its brotherhood make the decision and then instruct its President and/or its representative how to mark the ballot. Therefore, the Articles of Agreement now say to mail the ballot to the club address and that should not be changed. However, it should be the policy of the AMCC to direct the Secretary to clearly state in the minutes of the meeting at which nominations are made that the ballot has been sent to the club addresses. He should also be instructed as a matter of policy to include a separate statement in the envelope which he mails the minutes to the President/and/or representatives that the ballot has been sent to the club address.
