I. CALL TO ORDER: THE 92ND MEETING OF THE AMCC WAS CALLED TO ORDER BY PRESIDENT ROGER MCENNIS AT 11:42 AM ON JANUARY 14, 1989 AT THE DC EAGLE, WASHINGTON DC.

II. ROLL CALL:

A. PRESENT: BUCKS MC, CENTAUR MC, COMPANIONS MC, CYCLE MC, EMPIRE CITY MC, ENTRE NOUS, EXCELSIOR MC, MC FAUCON, HIGHWAYMEN TNT, IRON GUARD, LOST ANGELS, PENNSMEN, PHILADELPHIANS MC, PITTSBURGH MC, POCONO WARRIORS, READING RAILMEN, SHIPMATES, SPARTAN MC, THUNDERBOLTS MC, VANGUARDS MC, VIKINGS MC, WHEELS MC, AND WILDCATS MC.

B. PROXY: SNC LONDON

C. ABSENT: CRUCIBLE MC, LONG ISLAND SPUDS MC, NINE PLUS, PRAETORIANS, AND SCORPIONS MC.

III. GUESTS: GRIFFIN MC OF WILMINGTON DE, HARTFORD COLTS OF HARTFORD CT. AND C.O.M.M.A.N.D. OF BALTIMORE, MD.

IV. OFFICER REPORTS:

A. PRESIDENT: MR. MCENNIS REQUESTED A MOMENT OF SILENCE IN MEMORY OF PIERRE HENAULT.

B. VICE-PRESIDENT: MR MARENGO DEFERRED HIS REPORT TO NEW BUSINESS.

C. SECRETARY: THERE WAS NO SECRETARY'S REPORT. THE MINUTES OF THE 91ST MEETING WERE ACCEPTED AS MAILED ON A MOTION BY THE PITTSBURGH MC, SECONDED BY THE THUNDERBOLTS MC.

D. TREASURER: MR HAYSLETT SUBMITTED A WRITTEN REPORT WHICH WAS ACCEPTED ON THE MOTION OF SPARTANS MC, SECONDED BY THE VANGUARDS MC. ENTRE NOUS RAISED A QUESTION CONCERNING RECEIVABLES, WHICH, AFTER CLARIFICATION, CONCERNED THE LAST ASSESSMENT. MR HAYSLETT INFORMED ENTRE NOUS THAT THE LAST ASSESSMENT WAS COLLECTED IN FULL BY JULY OF 1987. THERE WERE NO OTHER QUESTIONS REGARDING THE TREASURER'S REPORT.

V. OLD BUSINESS:

A. ROSTER REVISIONS: ONCE AGAIN MR MCENNIS REQUESTED ALL ROSTER REVISIONS BE SUBMITTED TO THE CHAIR IN A TIMELY MANNER.

B. CLUB MEMBERSHIP VERIFICATIONS: MR MCENNIS REQUESTED THAT THOSE CLUBS WHO HAD NOT SUBMITTED THEIR VERIFICATIONS DO SO AS SOON AS POSSIBLE.

C. SANCTIONED CALENDAR: THE PROPOSED SANCTIONED CALENDAR WAS READ AND THE FOLLOWING ADJUSTMENTS WERE MADE:

ON A MOTION BY THE WHEELS MC, SECONDED BY CENTAURS MC, THE SANCTIONED CALENDAR, WITH ADDITIONS AND CHANGES, WAS APPROVED.

D. NOMINATION OF THE GRIFFINS MC FOR AMCC MEMBERSHIP: THE MOTION BY THE VANGUARDS MC, SECONDED BY THE PHILADELPHIANS MC, WAS BROUGHT TO THE FLOOR FOR ACTION. MR MCENNIS REQUESTED COMMENTS FROM THE SPONSORS AND THE VANGUARDS MADE A BRIEF STATEMENT OF SUPPORT. THE GRIFFINS ALSO MADE A BRIEF STATEMENT. ALL GUESTS WERE THEN REQUESTED TO LEAVE THE ROOM WHILE THE COUNCIL DISCUSSED THE MATTER. THE SHIPMATES SPOKE TO EXPRESS THEIR SUPPORT. AS THERE WAS NO FURTHER DISCUSSION ON THE MATTER, A SECRET BALLOT WAS TAKEN AND COUNTED BY MR MARENGO. THE VOTE FOR ADMISSION OF THE GRIFFINS MC TO AMCC WAS UNANIMOUS.

E. ATTENDANCE AT AMCC MEETINGS: MR MCENNIS ANNOUNCED THAT, AS INSTRUCTED, LETTERS WERE SENT TO THE PRAETORIANS, LOST ANGELS, CRUCIBLES, IRON GUARD, AND READING RAILMEN. MR MCENNIS STATED THAT NO RESPONSE WAS RECEIVED FROM THE PRAETORIANS AND CRUCIBLES. LETTERS WERE RECEIVED FROM IRON GUARD AND READING RAILMEN TO THE EFFECT THAT THEY HAD UNDERGONE SOME PROBLEMS THAT HAVE BEEN RESOLVED AND THAT THEIR PARTICIPATION IN THE COUNCIL SHOULD IMPROVE. IT WAS NOTED THAT THE LOST ANGELS, IRON GUARD AND READING RAILMEN WERE PRESENT FOR THE MEETING. ON A MOTION BY EMPIRE CITY MC, SECONDED BY WHEELS MC, THE PRAETORIANS WERE REGRETFULLY REMOVED AS A MEMBER OF AMCC. MR MCENNIS THEN NOTED THAT NO FURTHER ACTION COULD BE TAKEN ON THIS MATTER WITHOUT TWO (2) MEMBER CLUBS RAISING THE ISSUE IN WRITING.

B. SELECTION OF MEETING SITE FOR THE 93RD MEETING: MR MARENGO ANNOUNCED REQUESTS HAD BEEN RECEIVED FROM THE SHIPMATES, WHEELS MC, AND THUNDERBOLTS MC. IT WAS DETERMINED THAT AN APRIL MEETING WOULD BE PREMATURE AND THE SHIPMATES REQUEST WAS DECLINED. AS BOTH THE WHEELS MC AND THUNDERBOLTS MC HAD EQUAL POINT TOTALS, THE DECISION WAS PUT TO A VOTE OF THE COUNCIL AND THE 93RD MEETING WILL BE HELD DURING THE THUNDERBOLTS 18TH ANNIVERSARY, JUNE 9-10-11, 1989. MR MARENGO ALSO ANNOUNCED A REQUEST HAS BEEN RECEIVED FROM THE VANGUARDS MC FOR A MEETING IN OCTOBER. MR MARENGO STATED THAT THE REQUEST WOULD BE TAKEN UP AT THE 93RD MEETING.

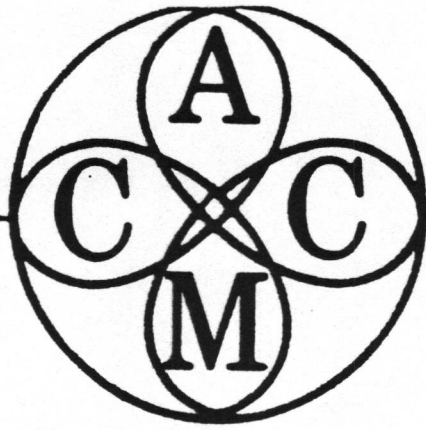
