- I. CALL TO ORDER: The meeting was called to order by Joe Marengo at 12:08pm.
- II. PRESENT: Bucks MC; Centaur MC; Companions; Empire City MC; Entre Nous; Excelsior MC; Griffins MC; Iron Guard; Long Island Spuds; Pennsmen; Philadelphians MC; Pocono Warriors; ShipMates; Spartan MC; Thunderbolts MC; Vanguards MC; Vikings MC; Wheels MC.
- III. PROXY: Cycle MC; Highwaymen TNT; Pittsburgh MC; SNC London.
- IV. ABSENT: Crucible MC; MC Faucon; Lost Angels; Nine Plus; Reading Railmen; Scorpions MC; Wildcats MC.
- V. GUESTS: Moor Cocks (Poughkeepsie, NY), Hartford (CT) Colts; and two guests of Keith Battin, Helge Hoff-Monsen and Don Clauten from Norway.
- VI. APPROVAL OF MINUTES: After a correction to the 92nd minutes indicating that C.O.M.M.A.N.D. was <u>not</u> a guest at the meeting, minutes accepted as mailed.
- VII. Joe Marengo, President, presented a gift of a silver scepter to the past president, Roger McEnnis, for his work with Council.

VIII. OFFICERS' REPORTS:

A. Treasurer: Gave financial report (enclosed) of A.M.C.C.
Recommended an assessment; noted that last assessment of \$10 was three years ago; only revenue to Council is sell of patches. MOTION: By T-Bolts, 2nd by Vanguards for a

- B. Secretary: No report.
- C. <u>Vice President</u>: Filed annual report of the corporation in DC; a \$30 fee paid.

IX. OLD BUSINESS:

- A. Roster Revisions:
 None reported; current (June 7) rosters and forms were available at the head table.
- B. Calendar Revisions:
 1. Centaurs released back to the ShipMates the dates of June 30 to July 4; OLYMPIA CANCELLED THIS YEAR.
 2. Philadelphians CANCELLED Tri-Cen VII, December 28 to January 2, 1990.
 3. SCORPIONS MC REQUESTED NOVEMBER 4 FOR ANNIVERSARY.
- C. Status of Crucible MC: Letter of March 20 to Council read by Secretary; MOTION made for Crucible MC to be dropped from roster for non participation at meetings or A.M.C.C. events. MOTION DIES and problem will be dealt with by Articles of Agreement, Article VIII, Sections B and C.

X. NEW BUSINESS:

- A. Fair and Equitable Hosting of A.M.C.C. Meetings:
 Should the policy adopted in 1986 be added to the
 Articles of Agreement? MOTION by T-Bolts that the Fair
 and Equitable Hosting policy (attached) be incorporated
 into the Agreement; 2nd by Excelsior. MOTION PASSES.
 However, Council will follow Article IX-Revisions in the
 Articles of Agreement. "...A vote on the acceptance of
 the revisions will be taken at the next scheduled
 business meeting."
- B. Council Historian:
 Mr. Marengo stressed the need for an individual to keep
 historical records for the Council. MOTION: by T-Bolts
 nominating Keith Battin as Council Historian; 2nd by
 Pennsmen. MOTION PASSES with one no and one abstention.
- C. Hartford Colts:
 The Thunderbolts of Connecticut recommended the Hartford
 Colts for membership into A.M.C.C. They were
 co-sponsored by the Vanguards MC, Empire City MC and the
 Pittsburgh MC. Vote for acceptance will be taken at the
 next meeting.
- D. Scheduling of 94th Meeting of the Council: Two clubs requested the next meeting; Vanguards MC and Empire City MC. According to Mr. Hard and the policy, Vanguards have 9 points and Empire City have 28 points;

therefore, the <u>94th</u> <u>MEETING</u> will be held during Empire City's XXV anniversary, October 6-9, 1989, at Arrowhead Ranch in Parksville, NY. Council agreed.


XI. GOOD AND WELFARE OF THE COUNCIL:




