Parksville, NY (Empire City M.C. 25th Anniversary)

- I. CALL TO ORDER: The meeting was called to order by President Joe Marengo at 4:09 pm.
- IIA. PRESENT: Bucks MC; Centaur MC; Crucible MC; Cycle MC; Empire City MC; Entre Nous; Excelsior MC; Griffins MC; Iron Guard; Long Island Spuds; Philadelphians MC; Pittsburgh MC; Pocono Warriors; Reading Railmen; ShipMates; Spartan MC; Thunderbolts MC; Vanguards MC; Vikings MC; Wheels MC.
- IIB. PROXY: Companions; Highwaymen TNT; Pennsmen; SNC London.
- IIC. ABSENT: MC Faucon; Lost Angels; Nine Plus; Scorpions MC; Wildcats MC.
- III. GUESTS: Moor Cocks (Poughkeepsie), Hartford (CT) Colts, C.O.M.M.A.N.D. (Baltimore), and Rangers (Cleveland).
- IV. APPROVAL OF MINUTES: Corrections to the 93nd minutes:
 - 1. VIIIA- Ed Glaser is Treasurer, not Secretary;
 - 2. XE4- Entre Nous not Vikings;
 - 3. XE8- Omission: Griffins, "GriffinFlight I" to be held Sept. 22 24, Wilmington, DE.

V. OFFICERS' REPORTS:

- A. Treasurer: Gave financial report of A.M.C.C.; as of November 18, Companions, L.I. Spuds and Nine Plus have not paid the assessment. Report accepted.
- B. Secretary: Read letters from the Bucks MC listing new officers; and from Reading Railmen regarding the death of a member.

- C. Vice President: No report.
- D. <u>President:</u> President Marengo appointed Marshall Kyle as Parliamentarian of AMCC during his term of office.

VI. OLD BUSINESS:

- Election of Hartford Colts: Asked all visitors and members of Hartford Colts to leave room. Initial vote taken on membership of Hartford Colts into AMCC. Need 23 affirmative for membership. Vote: 22 in favor, 2 nos. Vote did not carry. Discussion followed regarding the validity of counting absent member clubs as part of the overall percentage for membership approval. Griffins MC moved that "any voting member club absenting themselves from a regular council meeting without proxy will be counted as a vote in absention". Motion was seconded by Pittsburgh MC; motion carried with 21 in favor, 1 against, 1 abstention. The initial vote on the Hartford Colts was discussed and declaredinvalid in light of this discussion. Empire City MC moved that a revote be taken for the Harford Colts. Hartford Colts membership was approved with 20 in favor, 3 against, 1 abstention.
- B. Fair & Equitable Hosting of Meetings: Letter from the Thunderbolts to include this section in the Articles of Agreement; seconded by Vikings in writing; Griffins presented an amendment to strike the word "within" in paragraph 1, reading "...of the AMCC thrity (30) days." Vote taken, 21 for, 3 oppose; passed.
- C. Roster Revisions: MC Faucon reported; current (October 7) rosters and forms were available at the head table. Requested an address from the Long Island Spuds; none has been received.
- D. Calendar Revisions: Philadelphians gave up for 1989-1990 only, December 30 to January 1 to Iron Guard.
- E. Status of Crucible MC and Wildcats MC:
 1. Crucibles were in attendance; they have six (6) members and one (1) pledge. Motion tabled regarding removal from roster.
 - 2. Wildcats were not in attendance; Secretary read a letter from Michael Hayslett, former President of the Wildcats, stating his resignation in February 1989 from the Club and to the best of his knowledge, there are no remaining active members.

Council has not received any indication that the Club still exists and with regrets, votes to remove the Wildcats MC from the AMCC roster.


IX. ADJOURNMENT:
