Saturday, August 25, 1990
MC Faucon of Montreal, hosts

- I. CALL TO ORDER: The meeting was called to order by President Joe Marengo at 12:03pm at Contrecoeur, Quebec.
- IIA. PRESENT: Bucks MC; Centaur MC; Empire City MC; Entre Nous; Excelsior; MC Faucon; Griffins MC; Hartford Colts; Lost Angels; Pennsmen; Philadelphians; Pittsburgh MC; Pocono Warriors; ShipMates; Thunderbolts MC; Vanguard MC; Vikings MC; Wheels MC.
- IIB. PROXY: Companions; Cycle MC; Highwaymen TNT; Iron Guard; Reading Railmen; Scorpions MC; SNC London.
- IIC. ABSENT: Crucible MC; L.I. Spuds; Nine Plus; Spartan MC.
- III. GUESTS: Mike and Jerry from Vermont; Ron Carpenter, Pittsburgh MC; Ollie Allman and Hugh Gage, Centaur; Jerry Groman, L'Amis; Terry Brooks, C.O.M.M.A.N.D.
- IV. APPROVAL OF MINUTES: Minutes were read by Joe Sullivan, Secretary; one correction, V-A should read...balance in account is \$620.30. Correction noted; minutes accepted as amended.
- V. OFFICERS' REPORTS:
- A. Treasurer: Gave financial report of A.M.C.C.; as of August 24, balance is \$658.06. Clubs not having yet paid their assessment from last year: Long Island Spuds and Nine Plus. Treasurer's Report accepted as presented.
- B. Secretary: Read letter regarding new officers from Wheels M.C. and Bucks M.C.; read letters from Richard Focke, Treasurer, and Iain Birley, Secretary, of SNC London; read letter from Tarheel Leather Club regarding the upcoming Senate election in North Carolina with Jesse Helmes and asking for consideration for help to his opponent, Harvey Gantt of Charlotte; a copy of the letter with enclosures are a part of

the minutes.

The Secretary also read a letter received from The Companions Club of Philadelphia dated July 9, 1990, from the last president on record, Lenny Calabrese III, indicating that The Companions Club had folded, requesting that the Club name be removed from rosters and mailings. Also, Ed Glaser brought a letter from Frank Deninis, a member, indicating that the "rumor" was not true of disbanding. The Griffins moved that the conflicting letters be moved to Committee for all discussions. Committee chaired by Griffins, Marshall Kyle and composed of Jose Reyes, Empire City and Rob Martin, Vanguards.

C. Vice President: upon the absence of the Vice President, no report was issued.

VI.

OLD BUSINESS:

A. Status of Non-Participating Clubs: Nine Plus and Crucible MC; no communication from either Club. Secretary directed to send letter, registered return receipt requested to each Club advising them of status and of their intentions with the A.M.C.C.

B. CHANGES TO SANCTION CALENDAR; None.

C. C.O.M.M.A.N.D. MEMBERSHIP VOTE: Member from C.O.M.M.A.N.D. asked to leave while vote taken. Sponsoring Club representative, C.B. Miller of the ShipMate Club, spoke of C.O.M.M.A.M.D. and their work in the Baltimore/Washington area; an asset to the Council. Also, co-sponsor, Philadelphians Ed Glaser, spoke positively of C.O.M.M.A.N.D. Discussion held; some Clubs were concerned that with the lack of attendance at this event, they would be another "non-participating" club. Motion made to table the vote; results 8 to table, 12 against, 2 abstentions. Vote taken, 15 yes, 9 no; C.O.M.M.A.N.D. was not admitted into A.M.C.C. Motion made by Empire City to offer explanation of defeat and extend another invitation; we (A.M.C.C.) needs a little more time for more Clubs to get to know the C.O.M.M.A.N.D. membership. Seconded by Hartford Colts. Motion passed unanimously.

VII.

NEW BUSINESS:

A. New Business from the Floor: Peter Rapp II of Pittsburgh MC presented a piece of what could become the A.M.C.C. official tea service to the A.M.C.C. TFL to use in serving tea at official functions.

B. Scheduling of the 98th Meeting: Three Clubs had requests in--Entre Nous, Philadelphians, and Centaurs. Since the Centaurs were so late in filing their request, it was tabled until the next meeting. By computations, Entre Nous receives the next meeting with 23.41 points to Philadelphians 10.66 points. Unless there was urgent business, another meeting was not warranted so soon after the 97th Meeting. The Vice President recommended that the 97th meeting be scheduled at

the Philadelphians run at the end of the year.

Therefore, the 97th meeting of the A.M.C.C. will be held during TriCen VII, December 29 to January 1 in Philadelphia.

Business to be conducted will include the nomination of new officers, initial requests for sanctioned dates, and the Torrid Tuber nominations and award.



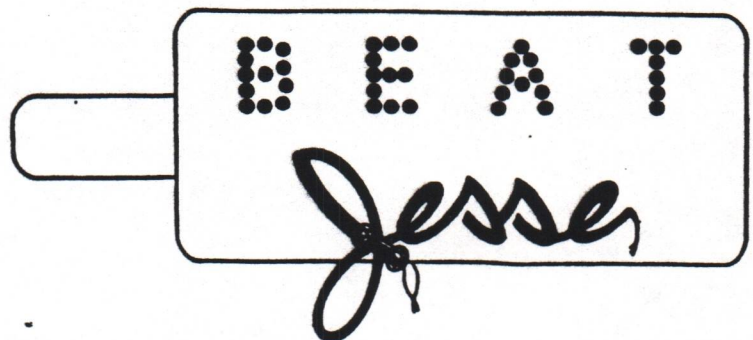

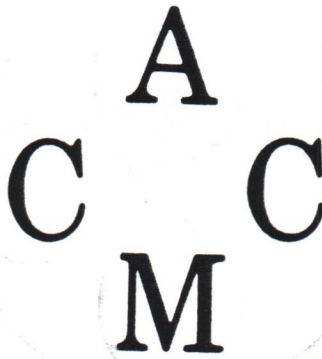

Dear Joe,

Here I go again! I received the minutes last Wednesday but didn't get around to reading them until this weekend. I did notice a few minor problems and they are as follows:

1. Section III. The listing for Jerry Groman is incomplete. It should read "Jerry Groman, L'Amis d'Entre Nous".

2. Section V, Paragraph B. ~~The date of the letter read~~ by Ed Glaser should also be included, if only to establish the fact that it was received six weeks after the letter you read. (NOTE: According to my notes, the entire matter came up under Old Business and therefore should be included in Section VI.)

3. Section VI, Paragraph C, line 13. The word "needs" should read "need".


4. Omitted from Section VII is the request made by John Bonnage, Centaur MC, to the effect that people refrain from stating that runs are "sold out" until they have been officially informed of that fact.

5. Section VII, Paragraph B, line 4. This section should have been prefaced with a statement that it was based upon a letter to the Council from Ray Hard, Vice-President. Further, it should indicate that Ray's determination was only that P-Town occurred too soon after Migration (Article VI, Paragraph B, Subparagraph E2 makes it an either/or situation, both conditions do not have to exist).

6. Section VII, Paragraph C5. Provencetown is spelled Provincetown.

7. The roster included with the minutes does not contain a listing for the Companions and their new mailing address as contained in their August 17, 1990 letter.

As usual, a pain in the butt. If any of my observations are incorrect, please let me know.
