



At our founding last May, Excelsior initially conveyed to the Club Fraternity our aspiration to evolve into a true cycle organization. We earnestly feel that such was our honest and immediate goal. The prospect of rapidly realizing this goal has at this time markedly diminished.

We acknowledge the incongruity. We concur that it is inappropriate for Excelsior to share undeservedly in the aura of a true cycle club. Therefore, at our general meeting on October 8, 1975, it was unanimously resolved that:

BE IT RESOLVED that the club de-emphasize the initial assertion that Excelsior is a pure motorcycle club and emphasize the fact that we consider ourselves to be an integral part of the motorcycle community and that we admire and encourage the sport of cycling...

Dear Emil and fellow club members,

First of all, thank you Bruce, for sending me a list of meetings, it is the first I have had since early August.

Since I am in California, I have asked Frank Olson to read this. I realize I could have sent it to Emil or to Rheinhold, but I would rather it be read by a fellow member rather than an officer.

Today I received a check in the mail for \$30.00 marked Marathon rebate 1975. I am returning this check herewith. To the best of my recollection, Tom Nassalrah made a motion, which was passed, that both Stanley and I have our Marathon fee's rebated by the club. I paid \$70.00 for two tickets, not \$30.00. If I am in error on this forgive my memory. But, I would like to point out that while I never asked for the rebate and appreciate the club's voting it, that trip, with the truck coming in from Pennsylvania to pick up the material for our party, returning it all to New York and then returning to New Hope cost me roughly \$150.00 including the Marathon fee, Gas, tolls, parking fee's in a garage with a loaded truck. We also closed the shop that weekend in order to have the truck and Stanley free. I find this check for \$30.00 an insult in the light of the motion passed. I did not, nor have I ever planned to bill the club for the additional expenses on the transportation of that weekend.

In April I wrote Emil a letter regarding the mailing of the Empire City mailing list, which I have put on scriptomatic cards in my office. I was supplied with 5 flyers for the mailing to over 100 people regarding our Tuesday bar nights. I had to send an office staff member to have 100 photocopies, had to use our own stock of plain envelopes and have my own personnel stuff and mail the flyers out. Colt Studio paid \$12.50 in postage and \$3.50 for the offset. I sent that bill in to Emil, since it came out of my company, not my personal funds. I have never been re-imbursed for that, nor for any subsequent expenses, that have been paid for by Colt.'s using our Postage meter for a mailing of any kind:

I cannot get to every meeting, in fact, I am able to get to few. I would more if I knew where they were, but being in this office often until past 7:30 makes it difficult and I have to schedule my time as many other members must. Advance notice of meetings and events is essential for this.

One final matter. On March 28, 1974, I donated to Empire City M.C., \$500.00 to set up an accident fund. There is an accompanying letter, of which I am including a copy. This fund is to be used for no other purpose than stated in the letter outlining it's structure. I would ask the Treasurer, as I have in the past, to keep a copy of this letter in that funds bank book for any quick reference to this structure.

Today, I am in LA, and have we got something for you... All the best to all.....

Dear Frank and fellow members of Empire City;

As I have mentioned to you Frank, I would like to see Empire City maintain a fund to assist a bike rider in the event he has an accident and needs some immediate funds for medical assistance. Therefore you will find enclosed a check made out to Empire City in the amount of \$500.00 to be deposited in a seperate savings account for that purpose.

I don't wish this to be a complicated set-up with paper work, applications, evaluations and time consuming efforts on the part of anyone. I would like the fund to exist known only to E.C.M.C., but available on a loan basis from E.C.M.C. to anyone, whether a club member or not. whoes needs come to our attention, either through one of our members or other club members, or word of mouth. All the riders in New York pretty well know one another and what is happening. The loan would be interest free and arranged according to the individuals abilities to rapay it. I also feel that the elected officers of the club should be the overseers of the fund and its disbursement. If they felt that there was some question on a situation that they could not resolve, then it could be put to the club membership. But, often, these things need speedy action and I believe E.C.M.C. elects people they have faith and trust in and who's judgement will be respected.

For newer members who were not part of Empire City when I had my near fatal accident, I would like them to know that Empire City raised nearly \$300.00 in cooperation with The Eagle on a bar night to help with my expenses. The club also picked up my wrecked bike and stored it in my garage. I don't think anyone in St. Vincents ever had so many visitors, not only club members, but other bikers and friends. I have not forgotten it and never will.

I have allways been pretty much a loner, and in many ways still am, but from E.C.M.C. I have learned more about brotherhood and companionship then I ever have before. It has made me very much more appreciative of my fellow human being.

Dear Emil,

Frank Olson gave me a listing for Empire City, as you know, to put on scriptomatic cards, which I had offered to do and keep in this office for any time we may wish to do a mailing.

Harry Earl supplied me, via the Eagle's nest, with 5 copies of a flyer advertising our Tuesday night bar and slide show.

We have done all the New York City scripto cards and run them through the addressing machine and then stuffed them and ran them through our postage meter.

The postage comes to \$12.50 and the flyers of which I had to have 100 offset, \$3.50.

When we finish doing all the scriptomatic cards, there should well be over 300 people and clubs on the Empire City mailing list

I offered our machinery here for this purpose and am donating the cards, but I do think very strongly that the next time we have a mailing to do, the club should arrange for it and gather people together to get it out. My staff of four people spent all afternoon typing the cards, running them off on the addressing machine, One had to run up to 33rd street to an instant copy offset company to get 100 copies of the flyer; Then they had to stuff 127 envelopes and then send them through our postage meter. Without envelopes, I used Colt Studio return address envelope. (Colt is not named on the envelope, just the PO Box number.)

I had expected to get enough flyers for the mailing, not just 5, and I did not expect that I would be the one to have the whole job done. I am not angry with you or anyone Emil, but I really can't have my whole office doing this work for us, which should be done by the club as a group.

Please forgive the tone of this letter if it sounds harsh, I don't mean it to be so, but we are overwhelmingly busy right now and this really came as a surprise.

Once again we are approaching the time of the year, when, according to the Articles of Agreement of the A.M.C.C., the Treasurer is to submit an audited statement of the A.M.C.C. books.

In the letter I sent to the Clubs last year, I pointed out that a full audit would have to be performed by a Certified Public Accountant. CPA's, as you know, do not perform their services cheaply, especially at this time of year, when we are entering the income tax season.

Therefore, last year, I supplied to each of the member Clubs, a full statement of all transactions, including all monies received and from whom, and all monies disbursed and to whom.

Due to the expense of the alternative, I plan to follow the same procedure this year. I am writing to each of the member Clubs, now, to inform you of this. If I do not receive a written objection by December 26, I will close the books as of December 31, 1975 and mail the statements on January 2, 1976.

I further stipulated that if any club had a question regarding any transaction, I would gladly supply copies of the checks and receipts, for that transaction.

Dear Jack,

In reading your column in the latest edition of Wheels Magazine I was puzzled to read the sentence "It is our understanding that the AMCC has forbidden any sanctioned run --- or any runs by AMCC clubs during 1976." Such is not the case. At the AMCC meeting held at Marathon, the members of the Council agreed to seek a one-day sanction for 1976 as opposed to the traditional weekend sanction. The rationale behind such a decision was to compromise between those member clubs of the Council who felt that no club runs should be held during 1976 and those who felt that all such club runs should be held in 1976. By deciding on a one-day sanction the clubs have the option of conducting a one-day sanctioned affair on their own or joining with another Council club and conducting a combined run in the familiar weekend format. The member clubs thus hoped to cut down on the number of Council-sanctioned weekend runs during 1976 and devote the resources thus saved in time, money, etc. to preparing jointly for the Affantic City Celebration.

It was further resolved at the meeting at the Levi Club anniversary Run in New York in November that any clubs conducting a joint run would have available a grace period from 6 p.m. to 12 midnight of the opening night of the Run, which time period would not require any sanctioning but would alleviate the situation of clubs which may have only one other club in geographic proximity.

Since representatives of the Vanguards were in attendance at these meetings I am perplexed to understand your written statement "that the AMCC has forbidden any sanctioned run...".

Because of this puzzling situation, I am enclosing a copy of the minutes of the Council meeting held during the Levi Club Run. You will note that the next Council meeting is not scheduled until the weekend of March 6 in Boston during the joint Entre Nous/Viking Run. You will also note that aresolution was passed at the same Nov. 15 meeting that any "clubs ruled to be in violation of the Articles of Agreement be given until Jan. 1, 1976 to conform to the guidelines established by the Council at Marathon for the giving of runs in 1976, and if the clubs refused to work within the framework of the Council that action be taken and that they be asked to leave the Council.". In that two clubs who had earlier stated their intention to hold their traditional weekend runs without co-sponsorship of other AMCC clubs were ruled by their brother clubs to be in violation of the Articles of Agreement(see p. 2, paragraph 4 under Old Business), it seems logical that the Vanquards too be ruled in violation of the Articles by having stated a similar intention regarding Oktoberfest.


On the basis of such a ruling I would appreciate a written response by Jan. 1, 1976 as to the Vanguards'intention regarding the holding of your Run in 1976. If you still decide to hold Oktoberfest under your sole sponsorship, no choice remains but to review your actions at the March Council meeting in the light of the motion approved at the last meeting, which stated "... and if the clubs refused to work within the framework of the Council that action be taken and they be asked to leave the Council.".

Please be assured that no one is more pained than I at the necessity of such a letter as this. However, the rules must be applied equally. In a true spirit of brotherhood several clubs have already put aside their own special plans and joined together with some of their brother clubs to abide by the rules which we have established for ourselves. In fairness to them and to all the clubs in the Council I urge you to join us and find us as united in celebrating our Bicentennial as those thirteen original colonies whose willingness to band together for the common good we will salute in Atlantic City next September.

The men of the Bucks M.C. have reviewed the four proposals presented to the Bicentennial Committee of A.M.C.C. and would like to com-

pliment these who were responsible for the proposals. We are aware that no other proposals are allowed to be presented at this time. We believe that the adoption of any proposal should be based on a clear majority of the clubs, not a simple plurality. We also believe that the four proposals do not take into consideration:

1- ECONOMICS:

- a- The current economic trend in the United States is one of uncertainty. Predictions, both public and private, do not show an economic upswing until mid or late 1976, at the earliest. With this in mind, many who normally would have considered a long term vacation or outlay of large amounts of money for leisure are re-evaluating their cash flow and will spend less in 1976 for such items.
- b- The current proposals are geared to a select affluent few. Since A.M.C.C. is a co-ordinating council for all member clubs and, Therefore, all club members, the cost of such a large run immediately excludes a majority of club members.

2- A.M.C.C. Purpose:

The purpose of A.M.C.C. is a co-ordinating council of all member clubs. In principle, with the current proposals, this is not the case. Instead of being a co-ordinating body, it is going into the travel business and ignoring the majority of members within the clubs. These proposals go against the very purpose of A.M.C.C.

3- CHOICE:

The current proposals do not give the average club member freedom of choice to select where and how he will celebrate the Bicentennial within his means and in the club scene.
