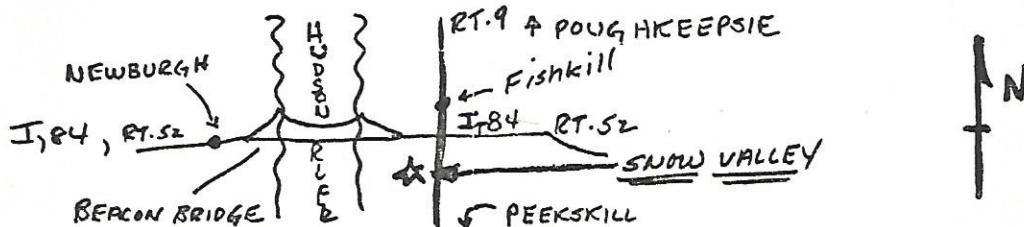
2. The scheduled Freedom Ride for May 19 to Albany to protest the helmet law was identified.

RALI Minutes 4/25/75

Due to extremely bad weather conditions and national shortage of pontoons, the meeting was called to order at 9:45 pm when a quorum of member clubs arrived.

Present: South Shore, Cross Island, Ryders of Brooklyn, North Shore, Indian, Queensboro.
Absent: Mercury Riders, Righteous, Newcomers, Twin Shores.
Guests: Blue Knights.

Paul Scarlata announced that his letter to Newsday (L.I. newspaper) was published in an edited form. This letter was written to protest the heavy coverage given to some of the local "outlaws" latest run ins with the law which tended to give all "bikers" bad publicity. It pointed out the difference between "bikers" and "outlaws" and the difference between "clubs" and "gangs".

STUDDING - Ryders of B'klyn have again asked that all clubs and individual members please write letters to commissioner Garvy protesting the studding of New York bridges. It was recommended that all clubs write a letter and all the members sign it. Details as to what the letter should contain could be found in last months minutes from AMA district #2 and Metro.

The Ryders pointed out that we should insist on having the city do a study on the effects of these studs so that even if we can't get them removed from bridges already studded or under contract to be studded we could prevent this menace from spreading to other areas of the metropolitan area and the rest of the country. THIS IS AN IMPORTANT ISSUE!

MIDDLETOWN - RALI has arranged discount rates for the races at Middletown. Members will receive a 25% discount upon presentation of your club card. The box office at Middletown will be provided with a list of RALI affiliated clubs. Each admission requesting a discount MUST have a valid club card.

TREASURER'S REPORT: previous balance \$77.05, receipts \$199.30, disbursements \$13.00, balance as of 3/25 \$186.30

PATCHES - RALI patches have finally arrived and are available through your club representative.

OVERNIGHTER - An over night event is in the planning stages for the weekend of Aug. 10. on private property owned by a RALI member in Monroe N.Y. We have asked each club to get an approximate head count of those who think they would like to attend. We are thinking of an approximate price of \$5.00 per head. This would include free beer, overnight camping, possibly swimming, a party complete with the Newcomers great band and some other surprise events. We would also like the clubs to discuss whether they would like RALI to provide pre-cooked, catered dinner which would probably mean a slightly higher admission price.

INCORPORATION - The process of incorporation is being taken care of by Ray Milik of South Shore under the guidance of one of Cross Islands newer members. We would like to thank this lawyer, who is not soliciting business, very much for his assistance.

NEW MEMBERS - Twin Shores was voted in unanimously.

An addition to By-law #4, sect B. was proposed and seconded. It will be voted on at next months meeting. The addition states: That unaffiliated members be accepted as per the constitution, (for a \$ 3.00 membership fee) to be put on the mailing list, but not be allowed to wear a RALI patch.

Jim Gray (Indian) has requested that a list be made of all affiliated clubs, stating their meeting time, date, address, phone number, and possibly membership requirements. This list could be given out to unaffiliated members who are interested in possibly joining a club.

DISTRIBUTION OF MINUTES - Sal (Ryders of B'lyn) proposed that a copy of the RALI minutes be sent out with AMA Dist. #2 and Metro's minutes. He said that if we got him the copies he would handle it from there. This was agreed to.

BLUE KNIGHTS - Carmine of the Blue Knights, a national motorcycle club made up of police and affiliated members described how his club functioned and some of there activities

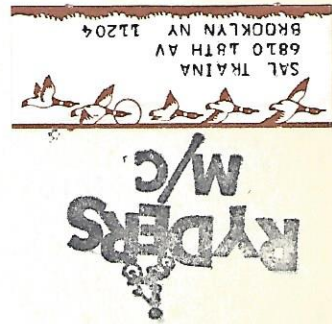
