

# Tr'ump's Supreme Court Choice is Dangerous



Judge Neil M, Gorsuch, 49, serves on the 10th Circuit Court of Appeals, gove which is based in Denver CO. He has been called "cerebral" and "brainy" by and various media outlets. But regardless how smart he is, he's a graduate of this can and ied at Oxford University as a Marshall Scholar, he's a radical Scalia-like that. "Originalist".

He answers Constitutional questions by considering how the Framers would have interpreted the plain language of the text back in the 18th Century. To Originalist like Gorsuch (and Scalia), the Constitution was encased in carbonite the moment it was written.

This approach is a convenient pretext for pushing a conservative ideology. Many of the basic Rights we consider essential to Modern Progressive Society, PRIVACY, GENDER and SEXUAL ORIENTATION EQUALITY, the RIGHT to CHOOSE, are not written explicitly in the Constitution. And there is little evidence that Alexander Hamilton and James Madison were thinking about a woman's right to choose (actually a woman's right to do anything) when they drafted and argued for ratification. Originalism also represent a shirking of the Judicial role: a lot has changed since 1789.

Judge Neil M. Gorsuch is unacceptable, his judicial record is hostile toward LGBT people. Through his decisions, he has promoted a vision of a society where the religious beliefs of employers can trump the law.

Lambda Legal's Fair Courts Project has conducted detailed research on

Judge Gorsuch. Here is a taste of his troubling record:

First and foremost, Judge Gorsuch's opinion on the 10th Circuit Hobby Lobby decision is disqualifying. It set a terrible and destructive standard that employers should be allowed to meddle in our sex lives and decide whether or not birth control is covered by the company's insurance plan.

We absolutely must not confirm a Supreme Court nominee who has ruled that the religious beliefs and moral judgments of employers can be forced upon their employees. It is a short hop from restrictions on birth control to restrictions on the intimate relationships and health care needs of LGBT people.

This trend of Religious exceptions lawsuits and statutes represent an extraordinary danger to our rights. Few of us expect the Supreme Court to reverse itself on marriage equality. But with Judge Gorsuch and four other conservative Justices on the Supreme Court, and the many other conservative Judges on the Appellate Courts, who are willing to cut out a doughnut hole in equality laws that would allow business to deny service to gay people if homosexuality violates their religious beliefs. They would even allow government officials to deny constitutionally protected rights to gay people and couples (including marriage) if doing so would violate their religion. If this dark future comes true, it would completely neuter marriage equality and public accommodation laws. And Gorsuch seems poised to do just that.

Judge Gorsuch also joined a 2015 opinion rejecting arguments made by an incarcerated transgender woman who was denied medically necessary hormone treatment and a request to wear feminine clothing.

Judge Gorsuch has expressed disapproval of civil rights impact litigation, writing in 2005 that "American liberals have become addicted to the courtroom ... as the primary means of effecting their social agenda on everything from gay marriage" to other issues.

We believe Judge Gorsuch is an especially dangerous jurist to place on the highest court in the land.

Reports have already suggested that he is more conservative than Justice Scalia was on the so-called Chevron doctrine. Sounds like a technical issue just for lawyers, right? Not so. In fact, Gorsuch's radical stance on this issue helps show why his confirmation would jeopardize the health, safety, and rights of all Americans.

The Chevron doctrine is named after a case decided unanimously by the Supreme Court in the 1980s concerning the Chevron energy company.

The doctrine, or rule of interpretation that came out of that case, says that power away from them, you neuter regulations. And that's the dream of courts should generally defer to administrative agencies' interpretation of the Koch brothers and the robber baron in the Whitehouse right now. laws that Congress has charged them with enforcing—particularly when the laws are ambiguous—unless the regulation or other interpretation is unreasonable. As a result, courts in numerous cases have upheld agency rules that protect health, safety, the environment, and other key subjects. As Ranking House Judiciary Member John Conyers has commented, the Chevron doctrine is crucial to the "ability of federal regulatory agencies to protect public health and safety."

For example, application of the Chevron doctrine was very important to courts upholding Department of Labor regulations that ensured that more coal miners suffering from black lung disease would receive adequate compensation from coal mining companies. The companies tried to contest the agency's rule, but relying on the Chevron doctrine, the corporations' argument was rejected. In another case, industry challenged an important EPA rule that toughened lead-based paint hazard requirements for home renovations under the Toxic Substances Control Act. Relying on cases decided under the Chevron doctrine, the D.C. Circuit Court of Appeals upheld the amended rule. It specifically noted that the amendment would help protect against "dangers to families with young

It specifically noted that the amendment would help protect against "dangers to families with young children," including approximately "23,000 children under age 6."

But Judge Gorsuch is a firm opponent of the Chevron doctrine. In fact, in a case that did not even specifically raise the issue, he wrote a long concurring opinion, commenting on the opinion that he himself wrote for the court majority, and argued that the Chevron doctrine should essentially be overruled, claiming that it represents "abdication of the judicial duty." Of course under the Trump administration, federal agencies may well not enact rules that impose reasonable limits on corporations and help consumers. But over the long run, as Rep. Hank Johnson has explained, eliminating the Chevron doctrine would "shield entrenched economic interests from liability and make it harder for agencies like the Environmental Protection Agency to deal with emerging public health threats." Both Johnson and Conyers spoke in opposition to a House Republican bill that would have attempted through legislation to eliminate the Chevron doctrine.

The Supreme Court ruled that they should defer to the experts who draft the regulations. Gorsuch disagrees with this, he thinks Judges know better. This is once again a pretext for forcing conservative ideology on policy. Regulatory Agencies are by nature, focused on regulations. When you take

The fact that Gorsuch's views accord with those of House Republicans is no surprise. Both are concerned with protecting corporations and not the interests of ordinary people. This is already clear from Gorsuch's record, and eliminating the Chevron doctrine would do more of the same.

In contrast, while sometimes criticizing specific decisions, Justice Scalia defended the Chevron doctrine, explaining that "in the long run, Chevron will endure and be given its full scope" because it more "accurately reflects the reality of government, and thus more adequately serves its needs." Thus Judge Gorsuch is clearly to the right of Justice Scalia on this issue, in a way that would ultimately help big business and harm ordinary Ameri-

One final point is cause for even more concern. Judge Gorsuch did not write his criticism of the Chevron doctrine in a law review article. Instead, it was in a concurring opinion in a case that did not directly raise the issue, and essentially urged that the doctrine be overruled. This clear willingness as an appeals court judge to urge the overruling of a Supreme Court decision less than 40 years old is extremely troubling for a Supreme Court nominee. Indeed, if he were on the Supreme Court, which actually can overrule its own decisions, he could work towards that result. Gorsuch's record suggests that other established Supreme Court decisions could also be targets for a Justice Gorsuch, including Roe v. Wade and Obergefell. That's part of why Gorsuch's radical views on the Chevron doctrine, to the right of Justice Scalia.

Judge Gorsuch, though by all indications, is a lovely man, is no friend to progressives. He will be a reliable Scalia-like vote to turn this country back. This only helps show why he should not be confirmed as our next Supreme Court Justice.

The Senate Democrats need to stand **FIRM** and **REJECT** this nominee, and any other, until Mr. Trump nominates someone who stands at the center, where most Americans are. Democrats have done it before, confirming Justice Anthony Kennedy over Robert Bork.

Please, Call both your Senators right now, to make sure they are getting blasted with an outpouring of grassroots contacts about the need to OP-POSE Gorsuch. Tell them Judge Gorsuch is unacceptable, and tell them why.



### Scorpio Rising

Written and Directed by Kenneth Anger, Circa 'Scorpio Rising' is an American experimental 28 minute short film, by Kenneth Anger, starring Bruce Byron, whom Anger asserts was 'half-

crazy', as Scorpio. Themes central to the film include the occult, biker subculture, homosexuality, Catholicism, and Nazism; the film also explores the worship of rebel icons of the era, namely James Dean and Marlon Brando. Like many of Anger's films, the film does not contain any dialogue, it instead features a prominent soundtrack consisting of 1960's pop, including songs by Ricky Nelson, The Angels, The Crystals, Bobby Vinton, Elvis Presley, and Ray Charles.. *'Scorpio Rising'* is considered by some to be the first drama film to feature a rock & roll soundtrack.

The film premiered in October 1963 at the Gramercy Arts Theater in New York City. When the film was screened at Cinema on Western Avenue, an Art Theater, in Los Angeles, it was protested by the American Nazi Party on the basis that it insulted their flag. The police were ultimately called to the site and arrested the theater manager for public obscenity and canceled the film's run. The case went to the California Supreme Court, where the case was settled in Anger's favor. Anger explained in an interview:

"When 'Scorpio Rising' was ,we've forgotten, in a sense, that it was a groundbreaker, legally. Because there are only a few flashes of nudity, genitalia, whatever in the film, I mean, they're very, very short and, if you blink, you won't even see them. At any rate, when it was shown, at the Cinema - it was called the Cinema on Western Avenue in Hollywood - the premiere run, someone denounced it to the Hollywood vice squad and they raided the theater and took the print. And the case had to go to the California Supreme Court to be freed and then it became, like, a landmark case of redeeming social merit. That was the phrase that was used to justify that it wasn't pornography. And, indeed, there's nothing pornographic about it. Somebody had to break the ice and have that kind of case at that time to establish the freedom, because, before then, the police could seize anything they wanted to. What I was doing on the West Coast, Jack Smith was doing on the East Coast with 'Flaming Creatures'. The two films happened at about the same time."

'Scorpio Rising' was praised by West Coast critics upon its initial release. When it was screened in New York City in 1964, 'Scorpio Rising' garnered additional positive reviews from 'The New Yorker', 'Variety', and 'Newsweek'.

Nora Sayre of 'The New York Times' reviewed the film in 1975 stating, "Oddly enough, the references to the nineteen-fifties,

which seemed dated and rather ponderous in 1965, don't make the film appear old-fashioned now. Admittedly, one then saw it in an unfortunate context – draped in the mystique of the underground, when a number of inferior films employed some similar imagery, such as the juxtaposition of Christ and hipsters, or close-ups of all-purpose skulls. But after a decade's education in put-ons, one can savor the impudent freshness of 'Scorpio' today."


