Newsweek, October 5, 2017— It's a rainbow-colored triumph whose A ceremony dedicating a rainbow flag flying meaning is compounded by the shadow President Donald Trump's administration has cast over LGBTQ rights. A rainbow flag will soon fly at the today with some controversy over the Na-**Stonewall National Monument in Manhattan**, the first such flag to be permanently placed on federal land and maintained by the National Park Service, activists announced on Thursday.

"It is a victory for our community to have these symbolic colors flying majestically over our Stonewall, designated as a National Monument by President Obama, even as our LGBTO brothers and sisters are under attack by the current regime in power;" Michael Petrelis, the LGBT and AIDS activist who initiated the effort, said in a statement. The rainbow flag will replace the National Park Service flag on the nautical flagpole outside Stonewall, says Ken Kidd, a friend of Petrelis's and a long-time New York City activist who is helping plan the unveiling ceremony.

The flag will officially go up at noon October 11. which is both *National* Coming Out Day and the 30th anniversary of the March on Washington for LGBT Rights. On that day in 1987, hundreds of thousands of people ers. gathered to call for an end to discrimination and more federal funding for AIDS research and treatment. The NAMES Project AIDS Memorial Quilt was unfurled and displayed for the first time on the National Mall with 1,920 panels covering a space larger than a football field to commemorate those who had died.

The Stonewall Inn, a bar located in the Greenwich Village neighborhood, was the site of protests that started on June 28, 1969, that are credited with **Park Service official who was to speak at the ceremony**, sparking the modern LGBT rights movement. Former President Barack Obama designated the bar a national monument on June 24, 2016. "Stonewall will be our first national monument to tell the story of the struggle for LGBT rights," said Obama, who had recognized June as Pride Month for several years.

But a lot can change in a year. Obama's successor broke with tradition and *campaign to reduce LGBT people to second-class American* failed to acknowledge Pride Month in 2017. The bar is known for the series of uprisings against police raids in 1969, a reaction that helped birth the modern LGBT rights movement. An area near the nightclub was designated a National Monument, under Park Service management, by President Barack Obama in 2016, reflecting the site's historic significance. The Stonewall itself remains a working bar under private ownership.

The rainbow flag, symbolizing LGBT pride, went up September 28, and the dedication ceremony was scheduled for today, which is National Coming Out Day as well as the 30th anniversary of the 1987 March on Washington for Lesbian and Gav Rights. The Park Service was set to take part in the ceremony, along with several LGBT activists, but pulled out as the day approached, drawing criticism from organiz-

Newsweek ran an article about the dedication last week, and it included quotes from some organizers denouncing the anti-LGBT actions of Donald Trump and his administration. By Friday night, a National Park Service flag flying alongside the rainbow flag had been removed and replaced with a New York City Parks flag, organizer Ken Kidd told The Washington Post. Then Barbara Applebaum, the canceled.

"Since planning began this past summer, the NPS had been wholly cooperative," Kidd said in a press release. "This abrupt turnaround as well as the NPS distancing itself from this event is more evidence of the Trump administration's Attorney General [Jeff] Sessions's support of religious rights over LGBT civil rights."

Washington had raised concerns about the flag dedication, according to the **Post**. The rainbow flag, he emphasized, has never been taken down, and the NPS has donated it to the city. *"It's still up, it's still flying there,"* Laird said of the flag. *"Visitors to Stonewall National Monument will see it, and 99 percent of them will not care if it's on our property or [the city's] property."*

Kidd agreed that the flag would serve as an important symbol. "That flag is flying proudly over the Stonewall National Monument in New York City," Kidd told the newspaper. "That symbol is up there for all the people who need it — and boy, do we need it more than ever."

Trump Kills Proposed Rule That Would Have Protected LGBT Seniors



The administration withdraws a proposed rule on equal treatment of same -sex spouses in long-term care, saying it's not needed

Donald Trump's administration has backtracked on yet another LGBT rights measure.

The Centers for Medicare and Medicaid Services, part of the Department of Health and Human Services, last week withdrew a proposed rule put forth in December 2014 to assure that same-sex spouses are treated equally to opposite-sex ones in long-term care facilities that receive Medicare and Medicaid funds, which most do.

The rule was proposed after the Supreme Court's **2013** *Windsor v. U.S.* **decision**, which struck down section 3 of the Defense of Marriage Act, therefore allowing the federal government to recognize same-sex marriages. *HHS wanted to assure that long-term care providers did not defer to state law on same-sex marriage, as not all states recognized it at the time.* Barack Obama was president when the rule was proposed.

According to the current administration, the high court's **2015** *Obergefell v. Hodges* decision, which legalized same-sex marriage nationwide, is sufficient to assure equal treatment of all spouses. *"We believe that the Obergefell decision has addressed many of the concerns raised in the December 2014 proposed rule,"* CMS administrator Seema Verma wrote in withdrawing the measure.

But some LGBT-focused health care groups say it's still necessary to include detailed antidiscrimination lan-

guage.

"The Supreme Court has previously found that the practice of specifically naming the groups who are protected from discrimination is essential for a nondiscrimination law to have its intended effect," noted a press release from Boston's Fenway Health. The release quoted Justice Anthony Kennedy's majority opinion in the **1996** Romer v. Evans decision, overturning Colorado's antigay Amendment 2: "Enumeration is the essential device used to make the duty not to discriminate concrete and to provide guidance for those who must comply."

Fenway Health also mentioned the threat to same-sex couples and LGBT people generally from *"religious objections" laws, such as the one in Mississippi. (The release was issued before Friday's unveiling of the federal government's "religious freedom" guidance, which allows broad application of such objections nationwide.)*

"It could not be more clear that the proposed CMS rule on the rights of LGBT patients and residents is still needed," Stephen L. Boswell, president and CEO of Fenway Health, said in the release. "By rescinding this important guidance, the likelihood has increased that LGBT people and same-sex couples will experience discrimination, neglect and abuse in long-term care, nursing homes, and hospitals."

How Trump Uses "Religious Liberty" to Attack L.G.B.T. Rights

In Mississippi, House Bill 1523, also known as the *Religious Liberty Accommodations Act*, also known as the *Protecting Freedom of Conscience from Government Discrimination Act*, went into effect last week. *It explicitly legalizes discrimination* if it is motivated by one of three beliefs: that marriage is a union between one man and one woman, that sexual relations can take place only within such a marriage, and that gender is an immutable biological characteristic. The law was passed last year and immediately blocked by a federal judge, but last week a circuit court reversed the ruling. *Doctors, lawyers, and adoption agencies, among others, are now licensed to discriminate on the basis of sexual and gender identity.*

laws; its enactment is only the latest blow to the rights of L.G.B.T. Americans in what has felt like a year of injuries. In February, the Trump Administration rescinded protections allowing transgender students to use the bathrooms of their choice. In May, President Trump signed an executive order directing his Attorney General to support and defend religiousfreedom laws like the one in Mississippi. In July, Trump tweeted out a ban on transgender service members. In September, the Justice Department filed a Supreme Court brief in support of a Colorado baker who refused to make a cake for a same-sex wedding. This month, October 6, 2017, Attornev General Jeff Sessions issued detailed guidelines based on Trump's religious-freedom executive order and, separately, instructed U.S. Attorneys to stop interpreting federal law as protecting transgender employees from discrimination on the basis of sex. This timeline is probably missing something; reversals in L.G.B.T. rights have been unremitting.

The "religious freedom" order means federal agencies and contractors could turn away LGBT people and others without repercussions.

Less than a year ago—one week before the election—Trump unfurled a rainbow flag, albeit upside down, during a rally in Colorado. Someone had It seems both inevitable and ominous that the re-litigation of LG.B.T. rights scribbled the words "*LGBTs for Trump*" on it. For much of his campaign, conventional wisdom held that Trump, the secular New Yorker that he is. would not pursue the anti-gay policies that his early supporter Sessions or his Vice-Presidential pick, Mike Pence, would advocate. But a strategy of homophobia has proved irresistible to Trump-and not just because of Pence and Sessions and the backing of the evangelical right. ("So many of them support what I do. They support me from the evangelical-Christian standpoint," the President said in an interview last weekend with Mike Huckabee.)

In the nostalgic campaign that got him elected, Trump promised to take his The era of Trumpian reversal is expressed in voters back to an imaginary past in which they felt better, more secure, and generally more great than they do in the present. *Nothing communicates* Trump's commitment to the past as effectively as reversals of LG.B.T. civil-rights progress—arguably the most rapid social change in American history. Supreme Court decisions in 2013 and 2015 granting equal status to same-sex marriages were rightly framed as breakthroughs: they had seemed nearly inconceivable just a few years earlier, a fantasy for some and a nightmare for others. It was inconceivable, too, that a Republican nominee for President would drape himself in a rainbow flag. The beliefs that the Mississippi law frames as religious-that marriage is a straight institution, that all people are born male or female and stay that way-are, in fact, many Americans' intuition of the way things always were and should be. The appeal of anti-queer gestures goes beyond the hard evangelical right, and probably includes some people whose best friends are gay.

The appeal can get broader still. Several of the ongoing or upcoming L.G.B.T.-rights battles will concern children. They always do: anyone who has studied the history of homophobic campaigns, or lived through one, knows that, in the end, it's always about the children. Indeed, "Protect the Children" is the battle cry of xenophobes of all stripes, but this call carries particular potency in matters of sex and gender.

Going back forty years, the first backlash effort against the gay movement in this country-Anita Bryant's "Save Our Children" campaign, which began in 1977 to oppose an anti-discrimination ordinance in Miami-trafficked in images of homosexual recruitment and child molestation. A decade later, following a campaign of panic centered on school materials and children's books, the British Parliament banned local for American Progress. governments in England, Wales, and Scotland from "promoting homosexuality." In the U.S., if a state with a religious-freedom law contracts out the placement of adoptive and foster children to private agencies, placements with L.G.B.T. families tend to dry up-because the agencies often hold a religious affiliation. Last month, the A.C.L.U. filed suit against the state of Michigan for turning away prospective adoptive and foster parents because of their sexual orientation. If the Mississippi law is challenged again, the case will also likely concern adoption or foster placement. A proposed reliaious-freedom bill in Oklahoma solelv concerns child-placement agencies. Another kind of case concerns transgender high-school students' right to use the bathrooms of their choice. A federal appeals court recently decided a Wisconsin case in favor of a transgender student, while a different appeals court must review a well -publicized North Carolina case, now that the Trump Administration has reversed course and the Supreme Court declined to hear the case.

will center on children. Much of the success of the American L.G.B.T. movement in the last couple of decades has turned on avoiding confrontation with the perception of the homosexual threat to children. The strategy has been either to desexualize gays by shifting the conversation to marriage and parenting or-brilliantly-to position transgender children as the ones in need of protection. As a result, advances in L.G.B.T. rights have occurred despite a parallel trend toward ever more policing of sex and an

intensifying drive for the protection of children from nearly everything.

The Department of Justice guidance document on religious freedom that actually creates a broad license to discriminate against LGBT people, single mothers. and others.

The long-anticipated guidance isn't a law or a rule, but it does lay out what the federal government's position will be in court cases and how federal agencies and contractors will operate, leaders of several civil rights groups explained on a conference call with reporters on October 6, 2017.

"For instance, an employee of the Social Security Administration or Department of Veterans' Affairs could refuse to process benefits paperwork for a widowed same-sex spouse, without repercussions," said JoDee Winterhof, senior vice president for policy and political affairs at the Human Rights Campaign. A nonprofit group with a federal contract could refuse to provide services to LGBT people, even in emergencies, and would not be in danger of losing its contract.

"This was meant to have a very deep and broad-reaching impact for people's day-to-day lives," she said.

The guidance means federal agencies, contractors, and more "can discriminate at will and the government will do nothing to stop it," added Winnie Stachelberg, executive vice president for external affairs at the Center

"Not only can contractors or federal grantees refuse service to LGBT they can be denied employment or fired", noted Louise Melling, deputy

discriminate," she said. "It is a deeply troubling guidance," she added.

In issuing the guidance, Attorney General Jeff Sessions wrote, "Religious liberty is, no one should be forced to choose between living out his or her faith not merely a right to personal religious beliefs or even to worship in a sacred place. Except in the narrowest of circumstances and complying with the law. Therefore, to the greatest extent practicable and permitted by law, religious observance should be reasonably accommodated in all government activity, including employment, contracting and programming."

Among the guidance memo's provisions are "Religious employers are entitled to employ only persons whose beliefs and conduct are consistent with the employers' religious precepts" and "As a general matter, the federal government may not condition receipt of a federal grant or contract on the effective relinguishment of a religious organization's exemptions or attributes of its religious character."

The guidance was issued pursuant to an executive order Donald Trump signed in May. Many activists expected that order to include "license to discriminate" language, but it did not, instead focusing on protecting the tax-exempt status of churches and other religiously affiliated organizations if they speak out on political matters. That order did, however, direct Sessions to prepare guidance on interpreting federal law on religious freedom.

"The guidance", Melling said, "is based on an extremely broad reading of the federal Religious Freedom Restoration Act of 1993. Religious freedom is an important value," she said, "written into the U.S. Constitution and frequently defended by the ACLU, but religious freedom doesn't give a person the right to harm someone else — which is exactly what this guidance does."

The good news, activists on the call noted, "is that state and local antidiscrimination laws remain in effect and that people who have suffered discrimination can sue under these laws." There are also federal courts that have held that Title VII of the Civil Rights Act of 1964 bans discrimination based on sexual orientation or gender identity, and lawsuits relying on this interpretation of Title VII are still being heard. The Trump administration has already argued against this interpretation and will continue to do so, but victims of discrimination should keep on suing, the activists advised.

Numerous LGBT and other progressive groups issued statements denouncing the guidance. A sampling:

"The guidance is meant to 'protect' the anti-LGBTQ child welfare worker who is opposed to placing young people in foster care with a lesbian couple. It is meant to 'protect'" the transphobic shelter worker who refuses to give a transgender person a place to sleep for the night. It's meant to 'protect' the anti-Semitic restaurant owner who doesn't want to serve a Jewish customer. It's meant to 'protect' the pharmacist who wants to make decisions for others and refuses to administer birth control. The list goes on. This guidance won't stand because we won't stand for it." — Rea Carey, executive director, National LGBTO **Task Force**

"Today's Department of Justice guidelines are merely a license to discriminate based on so-called religious freedom, and they are a disaster for this country. Neither individuals nor faith-based organizations - nor any other entity — have the right to elevate their religious beliefs above the laws that protect all Americans. For LGBT elders, this guidance is particularly dangerous because the vast majority of longterm care providers in the U.S. are operated by faith-based organizations. Religious freedom is a fundamental right, but the attorney general's directive is nothing but a license for businesses to discriminate. "Despite claiming to support our community, Donald Trump has proved to be one of the country's biggest threats to LGBTO people. Democrats support the right of LGBTQ people to live and work without fear of being fired or discriminated against simply because of who they are. It's time for Sessions to stop using the Justice Department as a tool for division and discrimination." - Democratic National Committee spokesman Joel Kasnetz

"The Department of Justice has declared open season on transgender and other LGBTQ people, hot on the heels of the Department of Health and Human Services denving necessary healthcare to hundreds of thousands of people. Also today, the **Department of Health and Human Services** issued two new federal rules gutting the Affordable Care Act's mandate for employer-provided insurance plans to include coverage for contraceptives at no cost to the employee. The rules will let any nonprofit or forprofit employer obtain an exemption from the mandate if they have a religious or moral objection to contraception, Reuters reports. As issued under President Obama, there was already a provision for religiously affiliated groups to have the coverage funded by their insurers rather than the organization, but some employers found that insufficient.

The Roman Catholic Church opposes all forms of "artificial contraception", and some religious groups believe that certain methods of contraception, such as *the birth control pill and the intrauterine device, actually* result in an early abortion.

The American Civil Liberties Union has filed a lawsuit Friday aimed at keeping the rules from going into effect, as did California Attorney General Xavier Becerra, Politico reports. Other progressive groups joined in denouncing the HHS move.

WHAT I DID LAST SUMMER... I have proudly never been on or any part of so-called Social Media (Thank Heavens; I don't speak Mandarin!) I only went on a gay chat room once which was quite enough. I found myself connected, electronically, to a trio of New Yorkers and there, it was raining. They all said they were bored. Given that, New York is one of the most lively, fascinating, and busy cities on the planet, and, I would charitably deduce that collectively their IQs would total at least twenty, I kindly suggested reading, trying the Public Library, or if all else fails, walking over to Three Lives which never seems to shut. They said: "Fuck You", to which I replied: "Not a Chance", logged off and headed for the nearest gin bottle and a copy of Ella Wheeler Wilcox today a somewhat obscure, turn of the century erotic-expressionist poetess whom Virginia Woolf called the Madame de Stael of Milwaukee. (My favorite of her poems is one about a sunbeam and a moonbeam getting it on under a damp rock and conceiving the first opal! Then there is one called "The Old Stage Queen" which is about Amanda Reckonwith!) Which brings us to exactly what kept me busy during the summer months. Some years ago, quite intrigued about Virginia Woolf, brilliant writer, and sometime Queen of the Bloomsberries, and having read a rather polite biography of her written by a nephew, Quentin Bell, I had heard of a new, wonderfully constructed new biography of her by the exceptional Hermione Lee. Ms. Lee's very detailed, frank, and praiseworthy biography clocks in at 867 pages, including very detailed footnotes; not one page wasted time, but in its own professional way, an inspiration. The book doesn't begin in the traditional: I was born on, in, and at style of Charles Dickens, but in a welter of literary furor which typical of the gestation of Woolf's writing, returning to the vital statistics well down the road. (Woolf could have benefitted from Lee's technique in her biography of friend and art historian Roger Fry, her lone venture in that genre, and generally felt to be one of her least effective writings which all things being relative is not exactly shabby.) Lee's style works well because her lifetime in Woolf's extraordinary databank seems to have appeared in her writings. They say that in periods of depression and at the very end of her life (Spoiler Alert, unless one has read or seen Michael Cunningham's "The Hours"), Virginia Woolf heard voices leading her into madness. My speculation is that Virginia Woolf knew so much and possessed so much information that her brain couldn't fully shut down before drowning herself in the River Ouse. Woolf read everything of quality; Proust, passionately, the Russians, the classics, Shaw. etal. Reading great writing can be an enormous satisfaction, a decided antidote to any sort of boredom: such a thing found no time in her extremely active life. Virginia Woolf, who survived a restricted, sometimes sexually cruel childhood, turned to other women for physical affection, though she shared with her husband Leonard, a deep and abiding marriage. In addition to her famous novels, she wrote essays, criticism, and short stories; she worked with Leonard, largely hand setting type in the Hogarth Press which they founded. Together, they introduced and promoted writers as widely diverse as Freud, Vita Sackville-West, Elizabeth Bowen, and T.S. Eliot. She, traveled widely, knew everyone, argued, debated, bore fools and difficult servants not easily. Reading great literature quite naturally cross references other great authors and to me, the mark of a great writer is to how many other fine authors and thinkers they will lead one; Virginia Woolf, to me, Van Wyck Brooks, Anthony Blunt, Walter Peter, Lytton Strachey Edmund Wilson, or Norman Douglas, . If any of this is challenging and you're still with me, reading this, I am delighted. One of our associate Unicorns has said that in every piece I write, I am stretching him a bit. This I take as a compliment. Another of you caught me using a double negative; another compliment! Even if you don't read. but paint, travel, antique, run, fish, learn fantastic play skills, oil vour leather, keep bikes dazzling, hug your pet skunk, or, ye gods, collect chipped china. There's so much to love before each of us enters that river. Waste no valuable time. CY
