As the Blue Wave continues to be a Reckoning Force in the 2019 Elections



LGBTQ candidates claim victory in the 2019 General Elections In 2019, what many have called an "offelection year," The "rainbow wave" of the 2018 elections continued Tuesday, with 112 openly LGBTQ candidates win-

ning their races, 106 Democrats, one Republican, one Independent, and four undeclared party affiliations, including a

number of successes in historically conservative states such as Virginia and Kentucky, and that's not counting those that are still too close to call.

In 2016, Republican presidential nominee won Kentucky with a 30-point margin over Democrat Hillary Clinton. In Virginia, where gerrymandered districts installed Republican majorities in both the state House and Senate in 2017, courts quashed the map and voters gave Democrats a sizeable majority in both chambers.

Victory Fund endorsed more LGBTQ candidates than in any other oddnumbered year in our organization's history. Reports Mayor Annise Parker, President & CEO, LGBTQ Victory Fund.

The Victory Fund, a group that trains, supports and advocate for lesbian, gay, bisexual, transgendered, and queer candidates who are pro-choice, said 80 of it's 111 endorsed candidates emerged victorious in the General Election. So far in 2019, the organization found 144 LGBTQ contenders won in 382 races, for an overall victory rate of 38 percent.

All nine openly LGBTQ candidates in Virginia won their races, including five

We won races in state legislatures and city councils and defended a huge slate of LGBTQ incumbents, including Virginia Delegate Danica Roem, who faced transphobic attacks from her opponent in the final weeks of the campaign. Delegate Danica Roem, the first openly trans person elected to statewide office, won a second term. with a margin of victory six percentage points larger than in 2017. Roem raised nearly twice as much money as her opponent, Kelly McGinn. McGinn had signed onto a letter calling marriage for same-sex couples *"morally repugnant."* In 2107, Roem ran on expanding Medicaid to her constituents and fixing the traffic-clogged Route 28 in Manassas.

"I'm grateful to represent you because of who you are, never despite,"Roem wrote on Twitter. "I'll see you Nov. 20 at our next #fixRoute28 public hearing."

Human Rights Campaign President Alphonso David said the results in Virginia sent *"a powerful message that Virginians support a bold, progressive vision for the future of the Commonwealth.*" David said HRC helped turn out 1.2 million *"Equality Voters"* in Virginia and spent over \$250,000 to elect *"pro-equality candidates across Virginia."*

Eliz Markowitz earned a first place spot and is headed to a runoff, nearly flipping a legislature that continues to push forward extremist anti-LGBTQ bills. We made LGBTQ history in Boston and Indianapolis, Mike Pence's backyard.

In Indiana, which gave Trump an almost 20-percentage-point margin over Clinton in 2016, the 25-member Indianapolis City Council picked up three *new* openly LGBTQ City Council members to join another who won reelection, the Indianapolis City Council tripled its number of LGBTQ representatives by re-electing Zach Adamson and newly electing Alison "Ali" Brown, Keith Potts and Ethan Evans onto the capital city's governing board. Brown and Evans are openly bisexual and married to spouses of the opposite sex. Evans and Potts both beat Republican incumbents.

Electing LGBTQ women to each city council for the first time. And we elected the first openly trans woman in Massachusetts history – a huge step forward for the state.

LGBTQ men ran in much higher numbers than their women counterparts, though queer women has a higher success rate, 46 percent to 37 percent, according to the Victory's election tracker. Transwomen specifically, who won in state races in Virginia, Utah, Massachusetts, and Iowa. The vast majority of LGBTQ candidates (83 percent) ran as Democrats, with just 2.4percent running as Republicans.

Pennsylvania, a state that President Trump won by less than one percentage point in 2016, experienced a *"blue wave"* of voter support for Democratic candidates. According to the Philadelphia Inquirer, Republican candi-

dates were "fading even on friendly turf." The Keystone State fielded the vertising" around transgender people's access to public accommodations largest number of LGBTO candidates than any other state: 14. And 13 of those 14, all Democrats, won, including Jessica Rothchild to the Scranton City Council.

Ohio also voted for Trump in 2016, but Democrats did well this year, and all 12 of Ohio's openly LGBTO candidates won, including new Toledo City Council member Theresa Gadus.

N.J. Akbar won his race for Akron Board of Education this evening, becoming the first openly LGBTQ Muslim elected in Ohio's history! This is a huge step forward for Ohio and ensures Akron's LGBTQ students and community will have an LGBTO voice advocating on their behalf.

"As one of the first openly LGBTO Muslims elected in United States history, N.J. will become a role model for so many LGBTQ students, students of color and Muslim students who too rarely see people like them in positions of power," Annise Parkers said in a statement.

N.I. is now one of the few out LGBTO Muslim elected officials in the nation – and his election tonight will be an inspiration to other diverse LGBTO people considering a run for office in Ohio and across the nation.

These candidates crossed the finish line thanks to generous supporters like vou. We raised more than \$370,000 for our candidates, including over \$120,000 to support Danica Roem's reelection campaign and help her fend off those anti-trans attacks. We provided campaign advice, fundraising support and media visibility for our candidates to help ensure they made history.

Not all noteworthy races in question have been called as of this writing. The nationally watched race for Texas' 28th state legislative district is heading for a runoff with no candidate having secured an outright majority. Democrat and out lesbian Elizabeth Markowitz ran against six Republicans and won roughly 40 percent of the vote. Markowitz will now face Republican Gary Gates in a runoff election that has not yet been scheduled by the governor.

But this year's story is about more than just the November Elections. Earlier we made 2019 the Year of the Lesbian Mayor - electing mayors for the first time in Chicago, Tampa and Madison, Wisconsin. I was on the ground with Lori Lightfoot when she won in Chicago and took my title as the highest-ranking LGBTQ mayor in U.S. history - and I was happy to pass the torch.

Anti-trans Ads: A Losing Strategy?

In several states that saw transphobic political attack ads flop against LGBTO-supportive candidates, political watchers are asking whether such ads will be effective heading into 2020's general election.

"As more information came out, we learned that we were a testing group for what the conservatives thought was going to be their new election tactic, in the way that trans bathrooms used to work for them, in the way gay rights used to work for them," Harman said. "They're testing the field to see if anti-trans bias is strong enough to propel them to victory in places that have unpopular candidates.'

"The answer is clearly NO." Hartman added.

"It's clear that that was effective," Haider-Markel said. However, "the ads in Kentucky about high school sports and thing like that don't seem to have the same traction." (People have seen these lies for what they are!)

"Tagging that to a candidate instead of an issue on the ballot is something different," Haider-Markel continued. "For LGBTQ candidates, success doesn't come from what your sexual orientation or gender identity is, success comes from focusing on the issues that people care about in their local community."

Danica Roem is "a prime example of that," Haider-Markel said.

Danica, a transgendered woman who was elected to the Virginia House of Delegates in 2017, was the highest ranking LGBTQ winner in this November's General Election. Her re-election makes her the longest serving transgender state legislator in US. history, and the first to ever win reelection.

"The success of trans candidates this Election Night, in states red and blue, is a warning to those using cynical campaign tactics to divide communities for their own political gain," Victory's Parker said in a statement.

Alphonso David, president of the Human Rights Campaign, echoed Parker, saving "the biggest topline takeaway" from the General Election is that "voters care about equality."

"What we saw in Virginia specifically is that anti-equality candidates have been using an outdated and offensive playbook that is not working anvmore." David said.

Other highlights among the General Election results:

In a Seattle City Council race, openly gay candidate Egan Orion appears to have beaten an incumbent in District 3. Orion, a gay activist and former organizer of Seattle's Pride parades, told local news outlets that he was "really frustrated" that the corporate giant Amazon supported his campaign through a political action committee that gave half a million dollars to his bid.

In the Texas House district outside Houston, lesbian Eliz Markowitz was the top vote-getter among six candidates and the only Democrat. But now she'll have to run against just one of those Republicans for the heavily Republican 28th District seat. The runoff will take place in December.

Former Florida State Rep. David Richardson will meet and opponent in a runoff for a seat on the Miami Beach Commission. Richardson came up just one point short of reaching enough votes to win the seat on Tuesday. Richardson won 49 percent of the vote; his runoff opponent won 38 percent.

In tiny Carrboro, North Carolina, openly lesbian Mayor Lydia Lavelle won The apparent victory of pro-LGBTQ Democrat Andy Beshear in Kentucky's reelection unopposed and openly gay newcomer Damon Seils won one of three seats on the town's Board of Aldermen - coming in second out of five candidates. In nearby Hillsborough, openly gay incumbent Matt Hughes that "anyone at any time could change teams for any reason", are not a came in first out of four candidates running for three seats on the Board of Commissioners.

> The Election however, wasn't all good news for the LGBTQ Community and our Allies, among the more stinging of the 21 LGBTO losses Tuesday was Telluride, Colorado, Mayor Sean Murphy, who lost his bid for reelection to a second term. Telluride was among only five incumbent LGBTO candidates who lost their reelection bids. In Houston, where five openly LGBTO candidates were running as Democrats for City Council, only two won. And outside Atlanta, in Doraville, Georgia, an openly gay City Councilman, Joseph Geierman, lost his bid for mayor.

Of the 112 openly LGBTQ candidates, 105 were running for local office. The "LGBT voters differ from non-LGBT voters in several ways. For examfield included 67 men, 44 women and one non-binary candidate.

As you can see, it has been an exciting "off year" for Victory Fund and for our entire community. When I first ran, I dreamed of media headlines like the ones we've seen in the past 24 hours. And because of dedicated supporters like you - this has become our new reality.

The Victory Fund estimates there are 765 openly LGBTQ elected officials nationwide. Parker said, "Americans are understandably focused on the Half of LGBT voters (51%) said that they were more likely to support "a 2020 presidential and congressional elections, but the LGBTO candidates who won tonight will arguably have a greater impact on the everyday lives of their constituents."

"We are building a pipeline of out LGBTQ leaders at every level of government," said Annise Parker, president of the LGBTQ Victory Fund and former mayor of Houston, "there is no time to rest. My team and I are going right back to work. In 2020, we expect to endorse more than 500 LGBTQ people for positions from local school boards to the U.S. Congress."


One-Fifth of LGBTQ.Adults.Aren't **Registered** to Vote

A report from the Williams Institute looked at LGBTO Americans and voter registration stats ahead of the 2020 election. Voting Rights Is an LGBTO Issue.

Nearly nine million LGBTO Americans are set to cast their ballots in November 2020, but a significant chunk of eligible queer adults have vet to register.

A new study from the Williams Institute, UCLA School of Law's think tank for LGBTQ issues in public policy, has examined the results of a 2019 national Ipsos poll for further insight in the voting habits of queer Americans. The data—collected from a random survey of 2,230 LGBTQ and non-LGBTQ respondents ages 18 and up, yielded some interesting finds:

Political affiliation of LGBT registered voters



Half of registered LGBT voters (50%) are Democrats, 15% are Republicans. 22% are Independents, and 13% said they identify with another party or did not know with which party they most identify. LGBT voters are racially diverse, nearly half (47%) are under age 35, and one-third have For example, they are more likely to be young, male, and live in urban at least a college education.

A 2019 national Williams Institute and Reuters/Ipsos poll asked LGBT and non-LGBT likely voters what they are looking for in a presidential candidate. In terms of political experience, LGBT voters were significantly more likely than non-LGBT voters to say that they would support a seasoned political candidate. The poll also found that LGBT voters were significantly more likely than non-LGBT voters to say they would support candidates who are black, Latino/a, or LGBT themselves. However, majorities of both LGBT and non-LGBT voters said that the race and sexual orientation of a candidate would not influence their vote.

About a third of LGBT voters said they were more likely to support a candidate because the candidate was black or Latino/a (34% and 35%, respectively). By comparison, 21% of non-LGBT voters said they were more likely to support a black candidate and 16% said they were more likely to support a Latino/a candidate.

41% percent of LGBT voters said they would be more likely to vote for a gay candidate and 34% said they would be more likely to vote for a lesbian candidate, compared to 10% and 11%, respectively, of non-LGBT voters.

Among LGBT voters, over one-quarter (28%) said they were more likely to support a candidate because the candidate was transgender or gender non -binary. By comparison, 9% of non-LGBT voters said they were more likely to support a transgender or gender non-binary candidate.

22% of LGBT voters are Latino/a, 13% are black, 61% are white, and 4% are other races or multiracial.

57% of LGBT voters are men and 43% are women.

One-fifth of LGBT adults (21%) and 17% of non-LGBT adults are not registered to vote.

Despite living under an anti-LGBTQ Republican administration, about one-fifth of LGBTQ adults in the U.S. (21%) are not registered to vote. This is after an unprecedented wave of openly LGBTQ politicians were elected into office in 2018, a trend that continued this most recent Election. and more than 50 Pride 2019 events nationwide featured voter registration booths to assist LGBTQ adults in the process.

For non-LGBTO adults in the U.S., that figure is lower: Researchers estimate that just 17% of cisgender, heterosexual adults nationwide currently remain unregistered.

Of the whooping nine million queer adults who are registered to vote, about half are registered as Democrats. Fifteen percent are registered as Republicans, while 22% of registered LGBTQ voters are independent. Across the board, queer voters are also significantly more likely to support black, Latinx, and LGBTO political candidates than their non-LGBTO voter counterparts.

In terms of gender, most registered queer voters are men (57%). Factoring race into the equation, most LGBTO voters are white (61%) or Latinx (22%), with black or multiracial Americans comprising the remaining percentages.

Christy Mallory, the study's author and the state and local policy director at the Williams Institute, added that LGBTO voters differ from non-LGBTO voters in "several ways":

Purging practices and other voter suppression tactics, like limiting voter registration opportunities and establishing strict photo ID requirements, are part of a broader problem: Our democracy is under attack. Barriers to political participation are rooted in, and perpetuate, the social and economic exclusion of people of color and low-income people. (Other examples include gerrymandering, the campaign finance system, and felony disenfranchisement laws.) As a result, historically marginalized communities remain unable to build power and inform conversations around policies of democratic exclusion. that directly affect them, on health care, affordable housing, education, labor. and more.

A demonstration of this is the disproportionate impact of voting restrictions on queer people of color and trans people. Strict voter ID laws, for example, are particularly burdensome for those who don't identify or present as the gender marked on their identification documents; voter registration requirements can present similar impediments. Purging processes like the one at issue in *Husted* can thus double-penalize trans and gender non-conforming people:

By purging them from the rolls because they have not voted.

Often when they don't vote, they can't get to the polls or take time off work.

The logistics of voting for low-income people, queer people of color, and trans peopled are two of the most economically insecure populations in the country-or because their needs aren't reflected in the agendas of the candidates on the ballot.

By forcing them to go through the burdensome voter registration process all over again before they can cast their ballots.

Meanwhile, agencies that are especially likely to interact with LGBTQ people are failing to provide voter registration opportunities. Although the **NVRA** requires states to offer these opportunities to people who receive government benefits, several states have failed to comply with this mandate, keeping opportunities from the more than 25 percent of LGBTQ people who receive food stamps. And, while the NVRA allows states to offer voter registration to detained individuals by designating the relevant state agencies as voter registration agencies, most states have not done so, which hurts queer and trans people, and especially queer and trans people of color, who are disparately policed and thus more likely to spend time in jail.

To create a democracy that works for all LGBTQ people, and all Americans, we need to improve our voter registration systems. We can do this by promoting the widespread adoption of automatic voter registration (AVR) and continuing to fight voter roll purges. AVR would give the large percentage of LGBTQ people who receive public assistance the chance to register immediately when they apply for or renew their benefits. Challenging aggressive purging practices would mitigate the burdens of re-registering and preserve individuals' constitutional right to vote, regardless of their socioeconomic circumstances. Such reforms would amplify LGBTQ voices in important policy debates and elect candidates who prioritize intersectional interests that align with those of queer communities.

Cruft beer; Drug Queens used to boost Ohio LGBTQ turnout in 2020 Election

COLUMBUS, Ohio — A nonpartisan coalition seeking to boost turnout among Ohio's LGBTQ voters in 2020 is launching a campaign that pairs voter registration with drag queens and craft beer.

Craft the Vote kicks off Thursday at Land-Grant Brewing Company. Similar events will follow at craft breweries around the state.

Organizer Brad Henry said, "the effort seeks to educate the many young gay voters disengaged from the democratic process and to generate enthusiasm through fun activities." The coalition estimates Ohio has 400,000 LGBTQ citizens and over 1.8 million who support equal rights.

A Vote Responsibly website the campaign's developing will help people vet news and information sources. The coalition won't advocate issue positions or endorse candidates.

Participants include the Human Rights Campaign, the League of Women Voters, Stonewall Columbus and Ohio State University.

COOKIE OF THE YEAR.... When heading into the city. I seem to be hooked on the diverse route 55 "flyer" buses, called by RTA, "The Cleveland State University Lines" (There are four destination versions and cheers to 80% of their drivers who refuse to obey the ridiculous 35 mph. speed limit imposed on the West Shoreway by the city at the behest of real estate interests developing egg crate housing in the Power House district of Hingetown.) These lines are the reason RTA built a number of brick and glass "cottages" for waiting passengers along Clifton Boulevard in Lakewood At the very end of the line, there are no covered shelters for citybound passengers. (The same is true for inbound Route 26, the Detroit Avenue bus.) These are arguably the coldest wind, snow, and rain swept stops in Lakewood. In fact on Sloane Avenue, near the end of the Lakewood portion of the route, there is only one shelter for eight stops, and it does not serve the inbound passengers. It is the conventional class and metal shelter, not the fine brick and mortar shelters which have been built on Clifton, most likely using governmental grants or other public funds. Somehow, Lakewood seems to have run out of money, or maybe someone in City Hall might have run off with it. During the non-operation of my printer (now fixed thanks to Chaz of the Empire City M.C.) I telephoned my councilman to report the discomfort and present need for shelters in the Sloane/ Detroit area. That was a month ago; I have received no reply. So, what a comfort to take shelter, when available at the Blackbird Baking Company, located at the corner of Sloane and Detroit, facing the bridge over Rocky River. **Blackbird** has become a major institution and destination for its splendid French style breads such as baguettes, epi, crusty pistolets, and levain (sourdough) loaves. The croissants, curiously unbent, are the best and in the area. The little seating area there does a very big breakfast and morning business there. Blackbird also has THE cookie of the year which is an oatmeal-cranberry number. The whole grain flavors are marvelous, the cranberries, lush and chewy, the sweetness seems derived perhaps from molasses or honey, and the butter is abundant (request plastic bags instead of the more absorbent paper!) Grabbing one or two of these in the morning, sheltering inside the bakery (room's allowing) awaiting the bus which stops at the back door, makes this happy gobbler feeling as if he's just consumed something really good and healthy for the old bod. I call these treats the Breakfast of Champions: not original but apt. These cookies, along with other favorites such as brownies, almond croissants, the marvelous burger buns, and the very flaky sticky buns tend to sell out early and are not always available at Blackbird's "Happy Hour", from five until six, when the shop closes. At that hour, the day's baking is sold at half price to make way for the next day's fare. This all started at a snail's pace, but soon word about the deal spread like wildfire and now there's quite a queue by five. Worry not, there is a periodical rack of freebies to read while your waiting, including on occasion, The Unicorn Horn. For more information, ring 216-712-6599. or view at www.blackbirdbaking.com. You can reserve product in advance for late pick-up, but full price will be charged. Another helpful suggestion - you might take along an extra cookie as a thank you for a favorite bus driver. In this gross era of American life, Cleveland is the one U.S. city I know where bus and rapid drivers are regularly thanked by a large number of their passengers. Hooray for us!.

We expect and are asking for a speedy process through the *Ohio Civil Justice Committee*, but we need your help!


